# THE UMBUTFO SWAZILAND DEFENCE FORCE (REMUNERATION) REGULATIONS, 1984

(Under Section 34)

In exercise of the powers conferred upon me by Section 34 of the Umbutfo Swaziland Defence Force Order, 1977, I, NTOMBI, NDLOVUKAZI AND REGENT, of the Kingdom of Swaziland on the advice of the Defence Council, hereby make the following Regulations:-
