THE ROAD TRAFFIC (AMENDMENT) BILL, 1988

(Bill No. 5 of 1988)

(To be presented by the Minister for Works and Communications)

MEMORANDUM OF OBJECTS AND REASONS

The object of this Bill is to amend the Road Traffic Act, 1965 in section 10(6)(a) to enable the Minister to allot registration marks and numbers for motor vehicles by regulation in the Gazette.

An Act to amend the Road Traffic Act, 1965.

ENACTED by the King and the Parliament of Swaziland.

Short title.

1. This Act may be cited as the Road Traffic (Amendment) Act, 1988 and shall be read as one with the Road Traffic Act, 1965 (hereinafter referred to as "the principal Act").

Amendment of section 10.

2. Section 10 of the principal Act is amended in paragraph (a) of subsection (6) by replacing it with the following—

- “(6) (a) allot to the motor vehicle in question a configuration of numbers and letters as the Minister may, by regulation prescribe and, if so directed by the Minister allot such insignia as the Minister specifies to be in addition to, in lieu of those letters and numbers; and”
