In exercise of the powers conferred by section 18 of the National Housing Board Act, 1988, the Minister for Interior and Immigration hereby issues the following Notice—

Citation.

1. This Notice may be cited as The National Housing Board Act (Appointment of Date for The Transfer and Vesting of Assets and Liabilities) Notice, 1988.

Appointment of date.

2. The appointed day for the vesting of all assets and liabilities of the Industrial Housing Company (Proprietary) Limited in the National Housing Board shall be deemed to have been the 24th day of April, 1988.

LEGAL NOTICE NO. 85 OF 1988

THE AVIATION ACT, 1968

(Act No. 31 of 1968)

THE AVIATION (AMENDMENT) REGULATIONS, 1988

(Under Section 21)

In exercise of the powers conferred by Section 21 of the Aviation Act, 1968, the Minister for Works and Communications hereby makes the following Regulations—

Citation and commencement.

1. These Regulations may be cited as the Aviation (Amendment) Regulations, 1988, shall be read as one with the Aviation Regulations, 1969 (hereinafter referred to as "the principal Regulations") and shall come into force on the 1st October, 1988.

Amendment of Appendix M.

2. Appendix M of the principal Regulations is amended—

(a) by adding at the end of "M.2. AERODROME CHARGES" the following—

"PASSENGER SERVICE CHARGE

- (1) All passengers departing on international flights from Matsapha Airport shall pay a passenger service charge of Five Emalangeni (E5.00) per passenger.
- (2) The following persons shall be exempt from the payment of the passenger service charge—
 - (a) crew members operating the aircraft;
 - (b) passengers in direct transit;
 - (c) passengers making a forced landing, or return due to technical reasons; and
 - (d) children under the age of three (3) years."
