LEGAL NOTICE NO. 66 OF 1989

ANIMAL DISEASE ACT, 1965 (Act No. 7 of 1965)

THE STOCK DISEASE (RABIES) REGULATIONS, 1989 (Under Section 3)

In exercise of the powers conferred on him by Section 3 of the Animal Disease Act, 1965, the Minister for Agriculture and Co-operatives hereby makes the following regulations—

Citation and commencement.

1. These Regulations may be cited as the Stock Disease (Rabies) Regulations, 1989 and shall come into force on 4th August, 1989.

Declaration of rabies guard areas.

2. The dipping tanks and other areas specified in Schedule I hereto are hereby declared to be rabies guard areas.

Isolation and confinement of dogs in rabies guard areas.

3. An owner of a dog in any rabies guard area shall isolate and confine it so as to prevent it from escaping from that area.

Destruction of dogs in rabies guard areas.

4. A government veterinary officer may destroy a dog in any rabies guard area which in his opinion has not been confined so as to prevent it from escaping from that area.

Presentation of dogs for innoculation.

5. A person who lives within a rabies guard area and owns a dog shall present it at the innoculation centre specified in Schedule II hereto for innoculation by the Director of Veterinary Services or his duly authorised agent during the time specified therein.

Offence and penalty.

6. Every owner of a dog in any of the guard areas who contravenes or fails to comply with regulation 3 shall be guilty of an offence and liable on conviction to a fine not exceeding E300.00 or imprisonment not exceeding a period of six months.
