LEGAL NOTICE NO. 137 OF 1995

THE INDUSTRIAL AND VOCATIONAL TRAINING ACT 1982
(Act No. 16 of 1982)THE TRADE TESTING (AMENDMENT) REGULATIONS, 1995
(Under Section 34)

In exercise of the powers conferred on him by section 34 of the Industrial and Vocational Training Act, 1982 the Minister for Labour and Public Service hereby makes the following Regulations:-

Citation.

1. These Regulations may be cited as the Trade Testing (Amendment) Regulations, 1995 and shall be read as one with the Trade Testing Regulations, 1989 (hereinafter referred to as the "Principal Regulations").

Amendment of Regulation 7.

2. The principal Regulations are amended in regulation 7 by replacing subregulation (2) (b) and (c) thereof with the following -

- "(b) in the case of an applicant for a Grade Two test, that he has obtained a Grade Three certificate in the trade or occupation in which he is to be tested, and has also completed a further 18 months' employment,

Provided that a period of up to 9 months at a Technical Training Institution approved by the Director for Training in such Trade or Occupation shall be deemed to be employment for the purpose of this Regulation.

- (c) in the case of an applicant for a Grade One test, that he has obtained a Grade Two certificate in the trade or occupation in which he is to be tested, and has also completed a further 30 months employment;

Provided that a period of up to 6 months of Higher Advanced Training at a Technical Training Institution approved by the Director for Training in such Trade or Occupation shall be deemed to be employment for the purpose of this Regulation."

LEGAL NOTICE NO. 138 OF 1995

ANIMAL DISEASE ACT, 1965
(Act No. 7 of 1965)

THE STOCK DISEASE (RABIES NO. 15) REGULATIONS, 1995
(Under Section 3)

In exercise of the powers conferred by Section 3 of the Animal Disease Act, 1965 the Minister for Agriculture and Cooperatives hereby makes the following Regulations:

Citation and Commencement.

1. These Regulations may be cited as the Stock Disease (Rabies No. 15) Regulations, 1995 and shall be deemed to have come into force on 14th September, 1995.

Declaration of Rabies Guard Areas.

2. The areas specified in the First Schedule (Schedule 1) hereto are hereby declared to be Rabies Guard Areas.

Isolation and Confinement of Dogs.

3. Every owner of a dog or cat in a guard area shall isolate and confine his dog or cat so as to prevent it from escaping from such guard areas. Such confinement and isolation shall remain in force until further notice.

Presentation of Dogs and Cats for Vaccination.

4. A person who owns a dog or cat and lives within the area specified in the first schedule to this Notice shall present his pets for inoculation at the designated vaccination centre and on the time specified in schedule 2.

Offence and Penalty.

5. An owner of a dog or cat who fails to comply with Regulation 3 shall be guilty of an offence and upon conviction, liable to a fine not exceeding E300.00 or in a default payment, to imprisonment for a period not exceeding 3 months.

Destruction of Dogs and Cats in Rabies Guard Areas.

6. Government Veterinary Officers may destroy a dog or cat in any of the Rabies guard area if in his opinion, the dog or cat has not been confined so as to prevent it from escaping from such guard areas.
