THE LOAN (TWO INTERNATIONAL ROADS PROJECT) BILL 1995

(Bill No. 8 of 1995)

(To be presented by the Minister for Finance)

MEMORANDUM OF OBJECTS AND REASONS

The object of this Bill is to authorise the Minister of Finance to raise a loan not exceeding the equivalent of the sum of UA 24,730,000 (Twenty Four Million, Seven Hundred and Thirty Thousand Units of Account) approximately E121,551,410 (One Hundred and Twenty One Million, Five Hundred and Fifty One Thousand, Four Hundred and Ten Emalangen) from the African Development Bank for the purpose of financing the entire foreign exchange cost of the Project, and to provide for matters incidental thereto.

A BILL

entitled

An Act to authorise the Minister of Finance to raise a loan for the entire exchange cost of the Two International Road Project and to provide for matters incidental thereto.

ENACTED by the King and the Parliament of Swaziland.

Short Title.

1. This Act may be cited as the Loan (Two International Roads Project) Act, 1995.

Interpretation.

2. In this Act, unless the context otherwise requires -
“Agreement” means the Agreement referred to in section 3 and includes any document related thereto;
“Borrower” means the Government of the Kingdom of Swaziland;
“Lender” means the African Development Bank;
“Loan” Means the loan raised by the Minister in section 3;
“Minister” means the Minister of Finance.

Authority to raise Loan.

3. The Minister is hereby authorised to enter into an Agreement with the Lender for the purpose of raising a loan not exceeding the equivalent of UA 24,730,000 (Twenty Four Million, Seven Hundred and Thirty Thousand Units of Account) approximately E121,551,410 (One Hundred and Twenty One Million, Five Hundred and Fifty One Thousand, Four Hundred and Ten Emalangen) upon terms and conditions specified in this Act and upon such other terms and conditions as the Government may consider appropriate.

Loan charges and repayments.

4. (1) The loan shall be payable in over a period of fifteen (15) years after a grace period of five (5) years, commencing from the date of signature of the Agreement, in thirty (30) consecutive and semi-annual instalments, and the first such instalment shall be payable on the 1st of January or the 1st of July, whichever immediately follows the expiration of the grace period.

(2) The Borrower shall pay interest on the loan amount (disbursed and outstanding from time to time) at a rate per annum equal to, for each Interest Period, the Average Borrowing Cost for the last semester plus one half percent (0.5%)

(3) The Borrower shall pay a commitment charge at the rate of one percent (1%) per annum, on the undisbursed portion of the loan, which shall begin to accrue sixty (60) days after the date of the Agreement.

(4) The principal amount of the loan, the interest and the commitment charge shall be payable every six (6) months on the 1st of January and 1st of July of each year.

Charging of Loan.

5. The Loan shall be charged upon the Consolidated Fund and the assets of the Borrower.

Application of Loan.

6. The proceeds of the loan shall be used for financing the entire foreign exchange cost of the Two International Roads Project.

THE SWAZILAND NATIONAL PROVIDENT FUND (AMENDMENT) ACT, 1995

(Act No. 5 of 1995)

AN ACT

entitled

An Act to amend the Swaziland National Provident Fund Order, 1974.

ENACTED by the King and the Parliament of Swaziland.

Short title.

1. This Act may be cited as the Swaziland National Provident Fund (Amendment) Act, 1995, and shall be read as one with the Swaziland National Provident Fund Order, 1974 (hereinafter referred to as "the Order.")

Amendment of section 2.

2. Section 2 of the Order is amended by replacing the definition of "Minister" with the following new definition -

"Minister" means the Minister responsible for Labour and Public Service."

Addition of section 15 bis.

3. The Order is amended by adding the following section after section 15 -

"Power to amend Schedules

15 bis. The Minister may, by notice in the Gazette, amend any Schedule made under this Act."

Amendment of Section 26.

4. Section 26 of the Order is amended by adding the following subsection after subsection (2) -

"(3) A person who has received a benefit under this section shall not be entitled to a further payment of benefit thereunder until the expiration of a period of not less than two years from the date on which an invalidity benefit was last paid or deemed payable or if the benefit is paid in instalments, from the date when the first of such instalments was paid or deemed payable:

Provided that if at any time before the expiry of the two years the person becomes unemployed, he may be paid a further benefit under this section."

Amendment of section 31.

5. Section 31 of the Order is amended as follows -

(a) in sub-section (2) (a), by replacing the words "Minister for Finance and Economic Planning" with the words "Minister for Labour and Public Service";

(b) by replacing sub-section (2) (c) with the following new subsection -

"(2) (c) two persons experienced in financial matters who shall not be public officers appointed by the Minister for Labour and Public Service in consultation with the Minister for Finance"; and

(c) by adding the following sub-sections after sub-section (6) -

"(7) The investment committee shall submit to the Board through the Chief Executive Officer minutes of its meetings within fourteen days of each meeting.

(8) Decisions of the investment committee on a major investment shall not be implemented unless approved by the Board and the Minister as provided for under section 10 (1) of the Public Enterprises (Control and Monitoring) Act, 1989.

(9) A member of the investment committee appointed under subsection (2) (c) shall hold office for a period not exceeding three years and on such other terms and conditions as may be specified in his instrument of appointment."

Amendment of section 32.

6. Section 32 of the Order is amended after the words "investment committee" by replacing the full-stop with a comma and adding the words "provided that the provisions of section 31 (8) have been satisfied."

Replacement of section 38.

7. Section 38 of the Order is replaced with the following new section -

"Priority of payment.

38. Where an employer becomes insolvent or, if the employer is a company, where the company is wound up, any contribution, penalty or other payment due to the Fund in respect of any employee by such employer, shall be a preferent claim to the same extent as other preferent claims are treated under the Insolvency Act, 1955."

ANIMAL DISEASE ACT, 1965
(Act No. 7 of 1965)

THE STOCK DISEASE (RABIES NO. 17) REGULATIONS, 1995
(Under Section 3)

In exercise of the powers conferred by Section 3 of the Animal Diseases Act, 1965 the Minister for Agriculture and Cooperatives hereby makes the following Regulations:

Citation and Commencement.

1. These Regulations may be cited as the Stock Disease (Rabies No. 17) Regulations, 1995 and shall be deemed to have come into force on 20th November, 1995.

Declaration of Rabies Guard Areas.

2. The areas specified in the First Schedule (Schedule 1) hereto are hereby declared to be Rabies Guard Areas.

Isolation and Confinement of Dogs.

3. Every owner of a dog or cat in a guard area shall isolate and confine his dog or cat so as to prevent it from escaping from such guard areas and such confinement and isolation shall remain in force until further notice.

Presentation of Dogs and Cats for Vaccination.

4. A person who owns a dog or cat and lives within the area specified in the first schedule to this Notice shall present his pets for inoculation at the designated vaccination centre and on the time specified in schedule 2.

Offence and Penalty.

5. An owner of a dog or cat who fails to comply with Regulation 3 shall be guilty of an offence and upon conviction, liable to a fine not exceeding E300.00 or in a default payment, to imprisonment for a period not exceeding 3 months.

Destruction of Dogs and Cats in Rabies Guard Areas.

6. Government Veterinary Officers may destroy a dog or cat in any of the Rabies guard areas if in his opinion, the dog or cat has not been confined so as to prevent it from escaping from such guard areas.
