LEGAL NOTICE NO. 50 OF 1999

THE UMBUTFO SWAZILAND DEFENCE FORCE ORDER, 1977 (Order No. 10 of 1977)

THE UMBUTFO SWAZILAND DEFENCE FORCE ORDER (REMUNERATION) REGULATIONS, 1999 (Under section 34)

In exercise of the powers vested in me by section 34 of the Umbutfo Swaziland Defence Force Order, 1977, I, MSWATI III, KING OF SWAZILAND, on the advice of the Army Commander, hereby make the following regulations -

Citation and Commencement.

1. These Regulations may be cited as the Umbutfo Swaziland Defence Force (Remuneration) Regulations, 1999 and shall be deemed to have come into force in respect of the 8%, on the 1st April, 1998 and, in respect of the 7%, on the 1st April, 1999.

Remuneration of Members of the Defence Force.

2. The remuneration of the members of the Umbutfo Swaziland Defence Force shall be as set out in the schedule hereto.

Revocation of Legal Notice No. 161 of 1997.

3. The Umbutfo Swaziland Defence Force (Remuneration) Regulations, 1997 are hereby revoked.
