# LEGAL NOTICE NO. 150 OF 2012

### ANIMAL DISEASE ACT, 1965 (Act No. 7 of 1965)

# THE STOCK DISEASE REGULATIONS, 2012 (Under Regulation 11)

In exercise of the powers conferred by Regulation 11 of the Animal Disease Act, 1965 the Director of Veterinary and Livestock Services issue the following notice.

#### Citation and Commencement

- 1. (i) This Notice may be cited as the Dipping of Stock Notice, 2011.
  - (ii) This notice shall be deemed to have come into force on the 1st November, 2012.

#### Compulsory Dipping of Stock

- (i) Subject to Regulation 11 (1) all owners of cattle in Swaziland shall dip their cattle once in every seven (7) days.
  - (ii) Not withstanding Sub-Regulation 11 (2) owners of cattle in the schedule here to shall dip their cattle in every fourteen (14) days.

#### Dipping Hours

3. Subject to any order to the contrary issued by an officer authorized under regulation 11, of the Stock Diseases Regulations of 1965 dipping hours under Regulations 2 (ii) of this notice shall be between 5:00am and 12:00 noon.

#### Revocation of Legal Notice No. 182 of 2011

4. Legal Notice No. 182 of 2011 is hereby revoked.

THE VALUE ADDED TAX (AMENDMENT OF SCHEDULE) NOTICE, 2012 (Under Section 84)

In exercise of the powers conferred by Section 84 of the Value Added Tax Act, 2011, the Minister for Finance issues the following Notice-

#### Citation

- (1) This Notice may be cited as the Value Added Tax (Amendment of Schedule) Notice, 2012.
  - (2) This Notice shall come into force on the date of publication in the gazette.

#### Amendment of Schedule

2. The First Schedule to the Value Added Tax Act No. 12 of 2011 is amended in clause 2 by deleting and replacing the definition of the words "insurance services" with a new definition as follows-

"insurance services" means services related to the provision of insurance, re-insurance or retirement funds, including related services provided by insurance and retirement funds intermediaries under the insurance or retirement funds law."
