In exercise of the powers conferred by Section 73 of the Water Act, 2003, the Minister for Natural Resources and Energy issues the following notice:-

***Citation and Commencement***

1. This Notice may be cited as the establishment of the Emandla Ekuphila Water User District Notice, 2014 and shall come into force on publication in the Gazette.

***Establishment of the Emandla Ekuphila Water User district***

2. (1) The Emandla Ekuphila Water User District is established.

(2) The registered office of the Emandla Ekuphila Water User District shall be situated within the Komati water control area with an address as shall be determined by the Members of the Irrigation District.

***Geographical Boundaries***

3. The Geographical Boundaries of the Emandla Ekuphila Water User District shall include the extent of land that lies within the Komati Downstream Development area in the Komati River Basin as reflected in the attached schedule to this Notice.

***Powers of the Emandla Ekuphila Water User District***

4. The powers of the Irrigation District as enumerated in Section 75 of the Water Act are as follows:-

(1) Exercise control over the operation and maintenance of waterworks in the District and the distribution of permitted volumes of water in accordance with permits.

(2) Exercise such powers with respect to enforcement of permits and the provisions of the Water Act.

(3) Take all reasonable steps to avoid the waste or misuse of water.

(4) Levy and collect rates and charges, subject to the approval of the Board to defray the costs of the district.

(5) Maintain true accounts of its expenditures, hold general meetings at least once a year and disclose accounts on its activities.


(6) Pass by-laws necessary to enable them to fulfill their obligations.
