THE INDUSTRIAL RELATIONS ACT, 2000
(Act No. 1 of 2 010)THE APPOINTMENT OF MEMBERS OF THE ESSENTIAL
SERVICES COMMITTEE, NOTICE, 2014
(Under Section 92)

In exercise of the powers conferred by Section 92 of The Industrial Relations Act, 2000, the Minister for Labour and Social Security issues the following notice:-

Citation and Commencement

1. (1) This Notice may be cited as the Appointment of Members of The Essential Services Committee, Notice, 2014.

(2) This Notice shall be deemed to have come into force on the 1st June, 2014.

Appointment of Committee

2. (1) The Minister for Labour and Social Security appoints the following persons as Members of The Essential Services Committee -

(a) Erickson Dlamini	-	Chairman
(b) Kingdom Mamba	-	Secretary
(c) Siphso Tsabedze	-	Government Representative
(d) Felton Mhlongo	-	Government Representative
(e) Jabulile Shiba	-	Worker's Representative
(f) Siphso Siyaya	-	Worker's Representative
(g) Sandile Gumedze	-	Employers' Representative
(h) Hezekial M. Mabuza	-	Employers; Representative

Terms of Office

3. The appointees shall remain members of the committee for a period not exceeding three years from the date of coming into force of this Notice.

Functions of the Committee

4. The Committee shall perform the following functions -

(1) conduct investigations as to whether or not the whole or part of any service is an essential service, and to decide whether or not to designate the whole or part of a service as an essential service;

(2) determine disputes as to whether or not the whole or part of any service is an essential service;

(3) determine whether or not the whole or part of any service is a minimum maintenance service; and

(4) Any other functions as provided for in the Industrial Relations Act, 2000.

Allowances and Fees

5. Members of the Committee including the Secretary shall receive allowances in terms of the relevant finance circulars issued from time to time.

6. Legal Notice No. 147 of 2010 is revoked.
