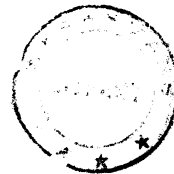

THE TELEVISION AUTHORITY ORDER, 1977

(No. 37 of 1977)

VIDEO CASSETTE RECORDER LICENCE REGULATIONS, 1978

(Under Section 11)

(Date of commencement: 7th. April, 1978)

Acting in consultation with the Television Authority of Swaziland and in exercise of the powers conferred on him by the abovenamed Order, the Honourable the Deputy Prime Minister is pleased to make the following regulations.

Citation.

1. These regulations may be cited as the Video Cassette Recorder Licence Regulations, 1978.

Period of Video Cassette Recorder Licence.

2. (1) The period of a valid current Video Cassette Recorder Licence shall be reckoned from the first day of July of any year to the thirtieth day of June of the following year.

(2) A person acquiring a television receiver at any time before the 30th June in any year shall be liable to pay a proportionate amount of the prescribed annual Video Cassette Recorder Licence fee for that year reckoned from the date of his acquisition of such receiver, to the nearest previous month end on a monthly scale.

Form of Video Cassette Recorder Licence and Amendment of Schedule to the Television Viewer's Licence Regulations, 1978.

3. (1) The following words shall be inserted in the Television Viewers Licence as set out in the Schedule to the Television Viewers Licence Regulations, 1978 after the words "Television Viewer's Licence" wherever they appear in the form, namely,

"and/or Video Cassette Recorder Licence"

(2) The form of Licence as set out in such Schedule and as amended by paragraph (1) hereof shall constitute a Television Viewers Licence and/or a Video Cassette Recorder Licence.

Change of address.

4. (1) A holder of a Video Cassette Recorder Licence shall in writing notify the Swaziland Television Authority of any change in his residential address.

(2) A holder of a Video Cassette Recorder Licence who fails to comply with paragraph 1 within fourteen days of such change shall be guilty of an offence and liable on conviction to a fine of one hundred emalangeni or imprisonment for one month.

Renewal of Video Cassette Recorder Licence.

5. A holder of a Video Cassette Recorder Licence shall renew it by paying the amount of the licence fee by not later than the 14th July in any year to the Swaziland Television Broadcasting Corporation Limited or Visionhire (Swaziland) Limited or any other person or authority who may hereafter be prescribed by notice in the Gazette and a newspaper circulating in Swaziland.

Inspection of Video Cassette Recorder Licence.

6. (1) The holder of a Video Cassette Recorder Licence shall exhibit such licence for inspection on demand by a person duly authorised thereto by the Swaziland Television Authority:

Provided that such demand shall be made at a reasonable time.

(2) A person who fails to comply with paragraph (1) shall be guilty of an offence and liable on conviction to a fine of one hundred emalangeni or one month's imprisonment.

Cost of Video Cassette Recorder Licence.

7. The cost of a Video Cassette Recorder Licence shall be E33,00 per year.
