THE MEDICAL AND DENTAL PRACTITIONERS ACT, 1970

(No. 3 of 1970)

THE REGISTRATION AND CONTROL OF PARA-MEDICAL
PRACTITIONERS (AMENDMENT) REGULATIONS 1978

(Under section 32)

(Commencement: 5th May, 1978)

In exercise of the powers conferred on him by the abovementioned Act and on the recommendation of the Swaziland Medical and Dental Council, the Honourable the Minister of Health is pleased to make the following regulations —

Citation.

1. These regulations may be cited as The Registration and Control of Para-medical Practitioners (Amendment) Regulations, 1978.

Insertion of regulation 4 bis.

2. The following regulation 4 *bis* is hereby inserted immediately after regulation 4 of The Registration and Control of Para-medical Practitioners Regulations, 1972 —

“Anaesthetist Assistants.

- 4 *bis* (1) Notwithstanding Regulation 4, any person who has passed the examination in Swaziland prescribed by the Council for anaesthetist assistants shall be entitled to registration as an Anaesthetist Assistant on production of a certificate that he has passed such examination under the signatures of the examiners and an approved certificate that he has for a period of not less than one year undergone a period of training as anaesthetist assistant in an institution approved of by the Council.

- (2) The registration fee shall be the same as prescribed in regulation 4.”
