THE RABIES NOTICE (MANZINI DISTRICT) STOCK DISEASE REGULATIONS 1933.

(Under Regulation 16)

(Commencement: 3rd July, 1978)

In exercise of the powers conferred on me by the above-mentioned Regulations I hereby make the following Order:—

- 1. This Order shall come into operation on the 3rd day of July, 1978.
- 2. All dogs in the dip tank and other areas in the schedule to this Notice shall be vaccinated against Rabies by means of Flury Strain anti-rabies vaccine.
- 3. All persons living within such listed areas and owning a dog shall present it at the inoculation centre mentioned in the schedule of this Notice for the purpose of being inoculated by the Director of Veterinary Services or his duly authorised agent during the time mentioned in the schedule.
