FIXATION OF POWDERED MILK AND ALLIED PRODUCTS
PRICES REGULATIONS, 1978

(Under section 24)

(Date of commencement: 28th July, 1978)

In exercise of the powers conferred on him by the abovementioned Act and after consultation with the Swaziland Dairy Board, the Honourable the Minister for Agriculture is pleased to make the following regulations:—

Citation and commencement.

1. These regulations may be cited as the Fixation of Powdered Milk and Allied Products Prices Regulations 1978 and shall come into force on the 28th July, 1978.

Maximum Wholesale and Retail Selling Prices.

2. The maximum wholesale and retail selling prices of powdered milk and allied products in Swaziland shall be as set out in the Schedule to this Notice.

Repeal.

3. Fixation of powdered milk and allied products published under Legal Notice No. 29 of 1978 is hereby repealed.
