(King's Order-in-Council No. 24 of 1978)

#### AN ORDER-IN-COUNCIL

#### entitled

A King's Order-in-Council to authorise the raising of a loan from the United States Agency for International Development.

(Date of Commencement: 3rd. November, 1978)

ENACTED by the King in collaboration with the Council.

Short title.

1. This King's Order-in-Council may be cited as The Rural Development Loan (No. 1) Order, 1978.

#### Interpretation.

- 2. In this Order, unless the context otherwise requires
  - "Agreement" means the Agreement referred to in section 3 and includes any documents relevant thereto;
  - "Loan" means the loan raised by the Minister in terms of section 3;
  - "Minister" means the Minister for Finance.

#### Power to raise loan.

- 3. The Minister is hereby authorised to enter into an agreement for the purpose of raising a loan not exceeding U.S. 5,400,000 Dollars (approximately E4,695,652) from the United States Agency for International Development upon the terms and conditions set out in this Order and upon such other terms and conditions as he may deem expedient.
- Loan charges and repayments.
  - 4. The principal amount of the loan shall be repayable over a period of forty (40) years, including a ten (10) year grace period. During the ten (10) year grace period, interest is charged at two percent (2%) per annum and three percent (3%) per annum thereafter.

Charging of loan.

5. The loan shall be charged upon the Consolidated Fund and the Assets of the Government of Swaziland.

#### Application of loan.

6. The loan shall be used to finance the purchase of heavy-earthmoving equipment for the Rural Development Area Programme.

#### THE POSTAL (AMENDMENT) (NO. 10) REGULATIONS 1978

(Under Section 105)

(Commencement: 1st October, 1978)

The Honourable the Minister for Works, Power and Communications is pleased to make the following regulations:—

Citation.

1. These regulations may be cited as the Postal (amendments) No. 10 Regulations, 1978.

Interpretation.

2. In these regulations:

"the principal regulations" means the Postal Regulations, 1962.

Amendment of Schedule B Part III(A) — Surface Mail:

3. Part III (A) of schedule B to the Principal Regulations is amended by replacing the various rates of Postage for parcels in force up to the Commencement of this Notice to the Countries listed with the new rates as set out in the first schedule attached hereto.

Amendment of Schedule B Part III(B) — Air Mail.

4. Part III (B) of schedule B to the Principal Regulations is amended by replacing the various rates of Postage for parcels in force up to the Commencement of this Notice to the Countries listed with the new rates as set out in the second schedule attached hereto.
