Short title.

1. This King's Order-in-Council may be cited as The Third Highway Project Development Loan Order, 1978.

Interpretation.

2. In this Order unless the context otherwise requires —

"Agreement" means the Agreement referred to in section 3 and includes any documents relevant thereto;

"Bank" means the International Bank for Reconstruction and Development;

"Development loan" means the loan raised by the Minister in terms of section 3;

"Minister" means the Minister for Finance.

Power to raise loan.

3. The Minister is hereby authorised to enter into an agreement for the purpose of raising a loan not exceeding Eleven Million United States Dollars (approximately E9,565,218) from the Bank upon the terms set out in this Order and upon such other terms and conditions as he may deem expedient.

Loan charges and repayments.

4. (1) The loan shall bear interest at the rate of 7.9% per annum.

(2) There shall also be payable on the loan a commitment charge at the rate of three-fourths of one percent per annum on the principal amount hereof not withdrawn commencing 60 days from the date of signature of the Agreement.

(3) The loan shall be payable over a period of fifteen years (15 years), the first instalment to be paid four years from the effective date of the Agreement.

Charging of loan.

5. The loan shall be charged upon the Consolidated Fund and assets of the Government of Swaziland.

Application of loan.

6. The proceeds of the loan shall be used for a road construction programme for the years 1979 through 1981 as follows:

"Minister" means the Minister for Finance.

Power to raise loan.

3. The Minister is hereby authorised to enter into an Agreement for the purpose of raising a loan not exceeding 8,000,000 Units of account (approximately E7.4 million) from the African Development Fund upon the terms set out in this Order and upon such other terms and conditions as he may deem expedient.

Loan charges and repayments.

4. (1) The loan shall be subject to the payment by the Government of a service charge at the rate of three-fourths of one percent (1%) per annum on the principal amount of the loan disbursed and outstanding from time to time.

(2) The principal amount of the loan shall be repayable over a period of forty (40) years, after a ten (10) year grace period, commencing from the effective date of the Agreement. Between the 11th and 20th year inclusive Government shall repay each year one percent (1%) of the principal amount of the loan in equal and consecutive half yearly instalments and thereafter shall repay each year three percent (3%) of the same in the like instalments until the total amount lent is amortized.

Charging of Loan.

5. The loan shall be charged upon the Consolidated Fund and the assets of the Government of Swaziland.

Application of Loan.

6. The loan shall be used to finance the construction of the Mkhondvo River—Mahamba Road.
