GENERAL NOTICE NO. 11 OF 1979

KING'S PROCLAMATION TO THE NATION OF THE 12TH APRIL 1973.

ISSUE OF A ROYAL COMMISSION OF ENQUIRY TO ENQUIRE INTO (A) ALL EVENTS RELATING TO THE 1977 GENERAL STRIKE AND BOYCOTT OF CLASSES BY SWAZILAND SCHOOL TEACHERS AND THE SUBSEQUENT RIOTING BY STUDENTS AND (B) THE EXISTENCE OF ANY STRUCTURAL, ORGANISATIONAL OR FUNCTIONAL SHORT-COMINGS IN THE CIVIL SERVICE.

In exercise of the powers conferred upon him by the abovementioned law and any other law relative thereto, His Majesty, King Sobhuza II, has been pleased to issue a Commission of Enquiry to enquire into the matters set out hereunder, to appoint the persons named hereunder to act as Commissioners in the Enquiry and to make provision for certain matters relating or incidental to such Enquiry.

- 1. The Commission shall enquire into and report on the following matters:—
 - (a) All factors that caused or contributed to the general strike and boycott of classes by Swaziland school teachers in 1977 and the subsequent rioting by students;
 - (b) whether any grievances, genuine or otherwise, existed on the part of the teachers and students and the root causes of such grievances;
 - (c) whether any act of neglect of duty or reprehensible lack of action by any person was the cause of or a contributory factor to such strike, boycott or rioting and, if so, the identity of such person;
 - (d) appropriate preventative measures to be taken in future for the purposes of avoiding a recurrence of a similar strike, boycott and/or rioting;
 - (e) the existence of any structural, organisational or functional short-comings in the Civil Service;
 - (f) appropriate remedial measures to be taken for the purpose of ensuring the maintenance of an acceptable standard of discipline and efficiency within the Civil Service;
 - (g) an enactment of any legislation which in the opinion of the Commission is appropriate to enhance the effectiveness of the existing and/or new legislative measures of controlling and regulating the Civil Service; and

- (h) any other matter which appears to the Commission to relate to the aforegoing and which in the opinion of the Commission or, in the public interest, to be enquired into and reported on.
- 2. The following persons are hereby appointed to act as Commissioners in the Enquiry, namely,
 - Mr. R. V. Dlamini
 - Mr. Ndawonde Sikhondze
 - Mr. Ndleleni Gwebu
 - Mr. Ben M. Nsibandze
 - Mr. John R. Masson
 - Mr. Wilson C. F. Mkhonta
 - Mr. Robert M. Mabila.
- 3. Mr. R. V. Dlamini is hereby appointed the Chairman of the Commission.
- 4. The provisions of sections 10, 11, 12, 13, 14, 15, 16 and 17 of the Commissions of Enquiry Act, No. 35 of 1963 shall, mutatis mutandis, apply in respect of this Commission.
- 5. The proceedings of the Commission shall be held in camera and the written report of the Commission together with such recommendations as it may think fit, shall be lodged with His Majesty the King within three months of the publication hereof which period may, however, be extended by His Majesty the King on good cause shown.
- 6. Mr. Robert M. Mabila of the Civil Service Board shall be the Secretary of the Commission.


