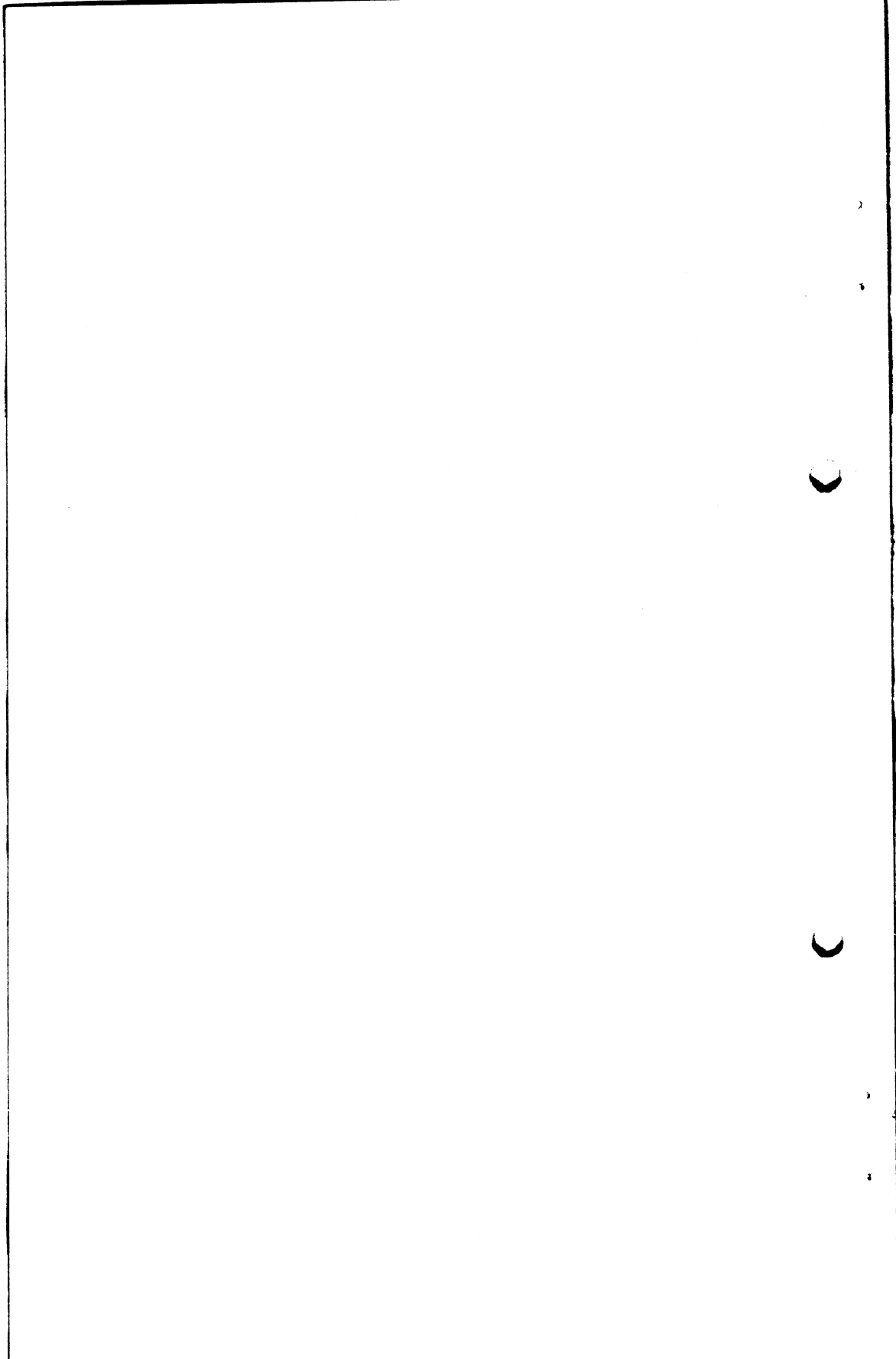

3. The First Schedule to the principal Order is amended by replacing the amounts E3.45, E2.88, E2.40 and E2.00 specified in grades A. B. C. and D thereof by the amounts E3.63, E3.02, E2.52 and E2.10 respectively.
