ANIMAL DISEASES ACT 1965

(No. 7 of 1965)

THE STOCK DISEASES REGULATIONS 1933 ORDER

(Under Regulation 11)

(Commencement 21st May, 1979)

In exercise of the powers conferred on me by the above-mentioned regulations, I hereby make the following order:—

1. This order shall come into operation on the 21st May, 1979.
2. All owners of cattle in Swaziland shall dip their cattle once every fourteen (14) days (that is) at an interval of thirteen (13) days between two dippings, (not including the two dipping days) except that owners of cattle depastured in the dipping tank areas listed below shall dip their cattle once every twenty-eight (28) days (that is) at an interval of 27 days between two dippings not including the dipping days.
