An Act to amend the Immigration Act, 1964.

(Date of Commencement: 24th. August, 1979)

ENACTED by the King and the Parliament of Swaziland.

Short title.

1. This Act may be cited as The Immigration (Amendment) Act, 1979 and shall be read as one with the Immigration Act, 1964, hereinafter referred to as "the principal Act".

Amendment of section 2.

2. Section 2 of the principal Act is amended by replacing the definition of "Minister" with the following —

"Minister" means the Minister responsible for Home Affairs;"

Amendment of sections 5, 6, 7, 17, 18, 20, 22, 26, 27, 28 and 32.

3. Sections 5, 6, 7, 17, 18, 20, 22, 26, 27, 28 and 32 of the principal Act are amended by replacing all references to section 31 (1), 31 (2) and 31 (3), as the case may be, with references to section 31.

Amendment of section 23.

- 4. Section 23 of the principal Act is amended
 - (a) in subsection (2)
 - (i) by replacing the word "Resident" with the word "Residence";
 - (ii) by replacing the reference to "subsection (4) (b)" with the reference to "subsection (5) (b)";
 - (b) in subsection (4) by replacing the words "so made" with the words "made under section 23 (1) (e)".

Amendment of section 31.

- 5. Section 31 of the principal Act is replaced by the following new section "Penalties.
 - 31. (1) A person convicted of an offence under a section which provides that the offender shall be liable to the penalties prescribed by this section shall be liable to
 - (a) a fine of not less than R200 and not more than R5 000; or
 - (b) imprisonment for a period of not less than five years and not more than ten years; or
 - (c) both such fine and imprisonment as are set out in paragraphs (a) and (b).

(2) Notwithstanding the provisions of any other law, a magistrate's court of the First Class shall have jurisdiction to impose the penalties provided for in subsection (1) upon a person convicted of an offence under this Act".
