ISSUE OF A ROYAL COMMISSION OF ENQUIRY TO ENQUIRE INTO (A) ALL EVENTS RELATING TO THE 1977 GENERAL STRIKE AND BOYCOTT OF CLASSES BY SWAZILAND SCHOOL TEACHERS AND THE SUBSEQUENT RIOTING BY STUDENTS AND (B) THE EXISTENCE OF ANY STRUCTURAL, ORGANISATIONAL OR FUNCTIONAL SHORT-COMINGS IN THE CIVIL SERVICE.

In exercise of the powers conferred upon him by the above-mentioned law and any other law relative thereto and good cause therefor having been shown, HIS MAJESTY THE KING has been pleased to extend the time within which the above-mentioned Commission shall lodge its Report with him by three months from the 2nd day of August, 1979.


