THE INDUSTRIAL RELATIONS BILL, 1979

---

(Bill No. 8 of 1979)

Clause 64(3) of the Industrial Relations Bill, 1979 (published in Vol. XVII, No. 964 of the Government Gazette dated 10th August, 1979) should read as follows:—

“(3) Any person who contravenes subsection (1) or subsection (2) shall be guilty of an offence and on conviction liable to a fine of E1000 or twelve months imprisonment.”

THE SWAZI ADMINISTRATION (AMENDMENT) ACT 1979

(Act No. 6 of 1979)

AN ACT

entitled

An Act to amend the Swazi Administration Act, 1950 (Act No. 79 of 1950).

*(Date of Commencement: 12th. October, 1979)*

ENACTED by the King and the Parliament of Swaziland.

*Short title.*

1. This Act may be cited as the Swazi Administration (Amendment) Act, 1979 and shall be read as one with the Swazi Administration Act, 1950, hereinafter referred to as "the principal Act".

*Amendment of section 1.*

2. The principal Act is amended by replacing section 1 with the following section —

*"Short title and application.*

1. This Act may be cited as The Swazi Administration Act, 1950 and shall apply to every person, whether a Swazi or not, ordinarily resident on land situate in a Swazi area".

*Amendment of section 2.*

3. Section 2 of the principal Act is amended by deleting the definition "chief" and by inserting the following in the appropriate alphabetical position —

"competent authority" means a person appointed by the Ngwenyama in Libandla for the purpose of administration in a Swazi area and includes a chief appointed under section 1 of this Act or any person holding such offices;

"Swazi area" means any area of land as so defined in the Definition of Swazi Areas Act, 1916 (Act No. 41 of 1916) or any other area of land held by the Ngwenyama in trust for the Swazi nation.

*Amendment of section 10.*

4. Section 10 of the principal Act is amended —

- (a) by deleting paragraph (1) from subsection (1);
- (b) by inserting the following new subsections immediately after subsection (2) —

“(3) The Ngwenyama in Libandla may at any time make an order, containing such conditions as he may consider appropriate for the removal of any person or any of his dependants living with him from one Swazi area to another Swazi area.

(4) An order made under subsection (3) shall be served on the person concerned by a messenger of the Ngwenyama in Libandla by exhibiting the original order to the person concerned and leaving a copy thereof with him or at his place of residence and by depositing another copy at the nearest Royal Swaziland Police Station.

(5) Any person who fails to comply with an order made under subsection (3) or any of the conditions attached thereto shall be guilty of an offence and liable on conviction to a fine of one hundred Emalangeni or six months imprisonment or both.

(6) In addition to the penalty prescribed in subsection (5) a person convicted of an offence under that subsection may be removed from the Swazi area to which the order under subsection (3) relates by a member of the Royal Swaziland Police Force without any further legal process.

(7) Any person who obstructs or hinders any other person who executes or assists in the execution of an order made under subsection (3) shall be guilty of an offence and liable on conviction to a fine of one hundred Emalangeni or six months imprisonment or both.

(8) No interdict by any court or other legal process for the stay of any order made under subsection (3) shall issue, nor shall any such order be suspended on the ground of any appeal against a conviction under subsection (5).

(9) A person whose removal has been ordered under subsection (3) or who has, in terms of subsection (6) been removed may, within a period of not more than thirty days from the date when the order was served upon him or such removal effected, apply to Ngwenyama for the review of (i.e. embule ingubo eNkhosini) such an order or removal.”

*Addition of section 10 bis.*

5. The principal Act is amended by adding the following new section after section 10 —

*“Unauthorised buildings.*

10 bis. (1) No person shall, without the permission of the competent authority, build a homestead in a Swazi area or remove such homestead from one place to another in any Swazi area.

(2) Any person who contravenes subsection (1) shall be guilty of an offence and liable on conviction to a fine of one hundred Emalangeni or six months imprisonment or both.

(3) Without prejudice to subsection (2), any building or similar structure erected in contravention of subsection (1) may be demolished by the competent authority without any order of court and no compensation shall be payable in respect of any building or structure so demolished”.
