

## THE POST OFFICE (AMENDMENT) (NO. 2) REGULATIONS, 1979

## (Under section 105)

In exercise of the powers conferred by section 105 of the Post Office Act 1962 the Minister of Works, Power and Communications hereby makes the following Regulations :--

#### Citation.

1. These regulations may be cited as the Post Office (Amendment) (No. 2) Regulations, 1979 and shall be read as one with the Post Office Regulations, 1962 (hereinafter referred to as the "principal Regulations").

Amendment of Schedule B. Part III 'A' Surface Mail.

2. Part III (A) of Schedule B to the principal Regulations is amended by replacing the rates of postage for parcels with the new rates set out in the First Schedule hereto.

Amendment of Schedule B Part III 'B' - Airmail.

3. Part III (B) of Schedule B to the principal Regulations is amended by replacing the rates of postage for parcels with the new rates set out in the Second Schedule hereto.
