THE BUILDING SOCIETIES (AMENDMENT) BILL, 1979

(Bill No. 11 of 1979)

(To be presented by the Minister for Finance and Economic Planning)

Memorandum in terms of the Standing Order of Parliament.

The object of this Bill is to amend various section of the Building Societies Act, 1962 (Act No. 1 of 1962).

A BILL

entitled

An Act to amend the Building Societies Act, 1962

Short title.

1. This Act may be cited as the Building Societies (Amendment) Act, 1979 and shall be read as one with the Building Societies Act, 1962, hereinafter referred to as "the principal Act".

Amendment of section 2.

- 2. Section 2 of the principal Act is amended
 - (a) by deleting the word "urban" from the definition "cession";
 - (b) by adding at the end of the definition "fixed period share" the words "except as otherwise provided under section 24 of this Act";
 - (c) in the definition "immovable property" -
 - (i) in paragraph (b), by replacing the expression "ten morgen (8.5653 ha.)" with the words "ten hectares";
 - (ii) in paragraph (c), by replacing the word "Minister" with the word "registrar";
 - (d) by deleting the word "urban" from the definition "mortgage":
 - (e) in the definition "subscription share", by adding at the end of paragraph (c) the words "except as otherwise provided under section 24 of this Act".

Amendment of section 17 (1).

- 3. Section 17(1) of the principal Act is amended
 - (a) in paragraph (g) by deleting the words "and with the Post Office Savings Bank of South Africa";
 - (b) in paragraph (j) by replacing the word "Minister" with the word "registrar".

Amendment of section 19

4. Section 19 of the principal Act is amended by deleting paragraphs (a), (b) and (c) and renumbering paragraphs (d), (e), (f), (g) and (h) as paragraphs (a), (b), (c), (d) and (e), respectively.

Amendment of section 22.

- 5. Section 22 of the principal Act is amended -
 - (a) by deleting paragraphs (a), (b) and (c) and renumbering paragraphs (d),(e), (f) and (g) as paragraphs (a), (b), (c) and (d), respectively.
 - (b) by replacing paragraph (d) with the following paragraph "(d) pay dividends on shares except out of profits".

Amendment of section 26.

6. Section 26 of the principal Act is amended in subsection (1) thereof by replacing the words "seventy-five per cent" with the words "ninety per cent".

Repeal of section 29.

7. Section 29 of the principal Act is repealed.

Amendment of section 32.

8. Section 32 of the principal Act is replaced with the following new section -

"Limitation of sums to be advanced to borrowers

32. Notwithstanding anything in this Act, no building society shall advance to any one borrower an amount exceeding such amount as may be, from time to time, prescribed by the registrar to apply generally to all borrowers."

Amendement of section 39.

- 9. Section 39 of the principal Act is amended by adding the following new subsection after subsection (6) -
 - "(7) For the purposes of this section, "net profit" and "net loss" shall be construed as the profit or loss, as the case may be, of a building society after deduction of expenses and of all dividends on the shares of the society during the financial year to which such profit or loss relates".

Amendment of section 42(2).

- 10. Section 42(2) of the principal Act is amended -
 - (a) in paragraph (a) by deleting subparagraphs (i) and by renumbering subparagraphs (ii), (iii) and (iv) as subparagraphs (i), (ii) and (iii), respectively.
 - (b) in paragraph (b) by replacing the words "twenty per cent" with the words "twelve per cent":
 - (c) in paragraph (c) by replacing subparagraphs (i) with the following "(i) savings deposits";
 - (d) in paragraphs (d) by replacing the words "thirty per cent" with the words "twenty per cent".

Amendment of section 45.

11. Section 45 of the principal Act is amended by deleting the words "the two directors and".

Amendment of section 48.

- 12. Section 48 is amended -
 - (a) in subsection (3) and (5) by replacing "members" with the words "members holding permanent shares"; and

(b) by adding after subsection (5) the following new subsection – "(6) Notice of an annual general meeting of a building society shall be given to all other members by a notice published in the Gazette at least twenty-one days prior to the date of such meeting".


