King of Swaziland

AN ACT
entitled

An Act to provide for the appropriation of a certain sum of money for the financial year commencing on the 1st April, 1981 and ending on the 31st March, 1982.

ENACTED by the King and the Parliament of Swaziland.

Short title and commencement.

1. This Act may be cited as The Appropriation (1981/82) Act, 1981 and shall come into force on the 1st day of April, 1981.

Charge to Consolidated Fund.

2. The Consolidated Fund is charged with such sum of money not exceeding in the aggregate one hundred and eighty-five million, thirty-three thousand Emalangeni (E185,033,000) as required for the services of the Government of the Kingdom of Swaziland during the financial year commencing on the 1st April, 1981 and ending on the 31st March, 1982.

Application of sum appropriated.

3. The sum appropriated by section 2 shall be applied to the services set out in the first column of the Schedule and in the respective amounts appearing in the second and third columns of that Schedule in respect of each service.
