

THE INDUSTRIAL RELATIONS (AMENDMENT) BILL, 1981

(Bill No: 11 of 1981)

(To be presented by the Deputy Prime Minister)

MEMORANDUM IN TERMS OF THE STANDING ORDERS OF PARLIAMENT

This Bill is designed to amend the Industrial Relations Act, 1980 by empowering the Minister responsible for labour in consultation with the Chief Justice to appoint a President of the Industrial Court.

A. NITHIANANDAN Acting Attorney-General

A BILL entitled

An Act to amend the Industrial Relations Act, 1980.

Short title

1. This Bill may be cited as the Industrial Relations (Amendment) Act, 1981 and shall be read as one with the Industrial Relations Act, 1980.

Amendment of section 4

2. The Industrial Relations Act, 1980 is amended in section 4 (2) by replacing the words "in the same manner as a Judge of the High Court" with the words "by the Minister after consultation with the Chief Justice".

(Act No. 28 of 1968)

THE PRICES OF POWDERED MILK AND ALLIED PRODUCTS (NO. 2) REGULATIONS, 1981

(Under section 24)

In exercise of the powers conferred on him by section 24 of the Dairy Act, 1968, and on the recommendation of the Swaziland Dairy Board, the Minister for Agriculture and Co-operatives hereby makes the following Regulations –

Citation and commencement

1. These Regulations may be cited as the Prices of Powdered Milk and Allied Products (No. 2) Regulations, 1981 and shall come into force on the 10th July, 1981.

Maximum wholesale and retail selling prices

2. The maximum wholesale and retail selling prices of powdered milk and allied products in Swaziland shall be as set out in the Schedule hereto.

Revocation of Legal Notice No. 28 of 1981

3. The Prices of Powdered Milk and Allied Products Regulations, 1981 are hereby revoked.


