(Act No. 31 of 1968)

THE AVIATION (AMENDMENT) REGULATIONS, 1981

(Under section 21)

In exercise of the powers conferred upon him by section 21 of the Aviation Act, 1968, the Minister for Works, Power and Communications hereby makes the following Regulations —

Citation.

1. These Regulations may be cited as the Aviation (Amendment) Regulations, 1981, shall be read as one with the Aviation Regulations, 1969 (hereinafter referred to as "the principal Regulations") and shall come into force on1981.

Amendment of Appendix M.

- 2. Appendix M. of the principal Regulations is amended
 - (a) by inserting below the title "APPENDIX M." the heading "AERODROME CHARGES";
 - (b) by deleting the heading "LANDING CHARGES" and replacing it with the heading "LANDING AND PARKING CHARGES";
 - (c) by deleting the words "Scheduled Aerodrome or Aerodromes at which the fees in Appendix M. shall apply as referred to in Regulation 153(1).

after item (6); and

(d) by adding at the end of Appendix M. after item (6) the following —

"Parking Charges

(7) (1) An aircraft shall be charged parking fees relative to its weight as reflected in its certificate of airworthiness or flight manual under standard sea-level conditions as follows —

2-00
3-00
4-00
7-00
9-00
11-00
13-00
17-00
50-00
100-00

- (2) Aircraft above 50,000 Kgs are prohibited from parking at Matsapa.
- (3) Parking charges shall be levied over a period of twentyfour hours or part thereof, only after the aircraft has been parked on the aerodrome for six or more hours.
- (4) The fees charged shall be paid in cash to the Airport Manager before the departure of the aircraft unless credit facilities have been granted in writing by a proper officer.
- (5) The following aircraft shall be exempt from the payment of parking fees
 - (a) aircraft registered is Swaziland and operated by a flying club or charitable organisation;
 - (b) foreign registered aircraft operated by a charitable or relief organisation:
 - (c) aircraft parked in a hangar;
 - (d) foreign registered aircraft used by the Government of the country of registration for State purposes;
 - (e) military aircraft; and
 - (f) aircraft engaged in search and rescue operations for aircraft believed to be missing or in distress.
- (6) The fees under Appendix M. shall apply to the Matsapa Aerodrome."
