THE WATER APPORTIONMENT (KOMATI RIVER) WATER CONTROL
AREA NOTICE, 1981

(Under section 69)

In exercise of the powers conferred by section 69 of the Water Act, 1967, the Water Apportionment Board hereby issues the following Notice —

Citation.

1. This Notice may be cited as the the Water Apportionment (Komati River) Water Control Area Notice, 1981, and shall come into force on 14th August 1981.

Apportionment of water.

2. (1) The apportionment, unless a contrary intention appears, shall be calculated —

- (a) as a percentage of normal September flow, approximately 362 cusecs (10.25m³/s) in relation to Gauge Station No. 26 at the Swaziland Irrigation Scheme weir with a maximum abstraction limited by a water duty or efficiency of use.
- (b) upon a water duty or efficiency of use which, subject to the discretion of the Board —
 - (i) in the altitude range from 0 to 530 metres, approximately 1 cusec (28.32 l/s) is sufficient to irrigate 80 acres (32.38 hectares);
 - (ii) above 530 metres, approximately 1 cusec is sufficient to irrigate 90 acres (36.4 hectares).

(2) An irrigator other than the Commonwealth Development Corporation below an altitude of 530 metres may, if the flow at Gauge Station No. 26 is more than 390 cusecs but does not exceed 402 cusecs, increase his abstraction as follows —

(a) MONTH	FACTOR
October	1.08
November	1.12
December	1.30
January	1.30
February	1.15
March	1.10

- (b) Flow in excess of 402 cusecs may be apportioned at the discretion of the Board as surplus flow.

(3) The Commonwealth Development Corporation may, in terms of its agreements with irrigators —

- (a) adjust the amount of water supplied and the times of delivery thereof to suit its operation; or

- (b) make a pro rata reduction to the amount of water supplied to the irrigator where the abstraction from the Komati River has been reduced or the water in the storage dam has become inadequate.

(4) The method of apportionment adopted under this Notice assumes that the water apportioned will be used for 24 hours in a day or be stored for later use.

General conditions attaching to permit — holders.

3. (1) Water-measuring or controlling devices may be installed by the permit-holder at the point of diversion or abstraction only as directed by and to the satisfaction of the Water Apportionment Board.

(2) No water-work or point of abstraction shall be moved or altered without the permission of the Water Apportionment Board.

(3) The water apportioned shall only be used by the permit-holders in the Schedule hereto and may not be hired out, sold or be otherwise dealt with on any farms other than those specified in the Schedule hereto.

Changes in ownership.

4. A new owner or occupier of any property or part thereof in the Schedule hereto, shall apply to the Water Apportionment Board for a permit entitling him to an apportionment in the Schedule.

5. The Water Apportionment — Komati River Water Control Area Notice is hereby revoked.
