MEMORANDUM IN TERMS OF THE STANDING ORDERS OF PARLIAMENT

The purpose of this Bill is to amend the Liquor Licences Act, 1964 so as to facilitate control of the consumption of liquor and to provide for other matters.

ENACTED by the King and the Parliament of Swaziland.

*Short title and commencement.*

1. This Act may be cited as the Liquor Licences (Amendment) Act, 1981, shall be read as one with the Liquor Licences Act, 1964 (hereinafter referred to as "the principal Act") and shall come into operation on such date as the Minister may, by Notice in the Gazette, appoint.

*Amendment of section 2.*

2. Section 2 of the principal Act is amended—
- (a) by deleting the definition "clerk"
  - (b) by replacing the definition "Minister," with the following —  
"“Minister” means the Minister for Home Affairs;”
  - (c) by inserting the following definition after the definition "rum"  
"Secretary" means the Secretary to a Board."

*Amendment of section 3.*

3. Section 3 of the principal Act is amended in subsection (2) by deleting the words "for Local Administration".

*Amendment of section 10.*

4. Section 10 of the principal Act is amended by adding the following subsection after subsection (9) —

- "(10) For the purpose of controlling the consumption of liquor, the Minister may issue directions to any Board and it shall be the duty of the Board to comply with such directions."

*Amendment of section 11.*

5. Section 11 of the principal Act is amended in subsections (1) and (2) by replacing the word "clerk" with the word "Secretary".

*Addition of section 11 bis.*

6. The principal Act is amended by adding the following new section after section 11 —

*“Appeals*

11. *bis.* An applicant or objector aggrieved by the decision of a Board in respect of the grant of, or refusal to grant, renew, remove or transfer a licence or in respect of any conditions or privileges attached to a licence may, within twenty-one days of such decision, appeal to the Minister whose decision shall be final and shall not be questioned in any court.”

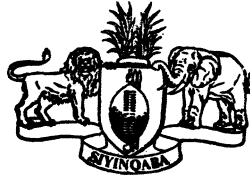

(c) by renumbering subsection (9) as subsection (8);

(Act No. 30 of 1964)

## THE LIQUOR LICENCES (AMENDMENT) REGULATIONS, 1981

In exercise of the powers conferred by section 49 of the Liquor Licences Act, 1964, the Minister for Home Affairs hereby makes the following Regulations:-

*Citation and commencement.*

1. These Regulations may be cited as the Liquor Licences (Amendment) Regulations, 1981, shall be read as one with the Liquor Licences Regulations, 1964 (hereinafter referred to as "the principal Regulations") and shall come into force on the 6th November, 1981.

*Addition of Regulation 2 bis.*

2. The principal Regulations are amended by adding the following Regulation after Regulation 2 —

*"Power of Minister to exempt.*

2 bis. The Minister may, in writing and upon such terms and conditions as he may impose, exempt any person from the application of any of these Regulations."

*Amendment of Regulation 3.*

3. Regulation 3 of the principal Regulations is amended —

- (a) in sub-paragraphs (a) and (b) of paragraph (1), by replacing "fifty rand (R50)" and "twenty-five rand (R25)" with "E67" and "E34", respectively; and
- (b) in paragraph (3) by replacing "ten rand (R10)" with "E15".

*Amendment of Regulation 5.*

4. Regulation 5 of the principal Regulations is amended —

- (a) in paragraph 3 (b) by replacing "ten per centum" with "fifteen per cent";
- (b) in sub-paragraphs (a) and (b) of paragraph (5) by replacing "one-tenth" and "two rand" with "fifteen per cent" and "E10", respectively.

*Amendment of Regulation 7.*

5. Regulation 7 of the principal Regulations is amended —

- (a) in paragraph (4) by replacing sub-paragraphs (a) and (b) with the following —
  - "(a) on Sunday, Good Friday and Christmas day, between 12.00 noon and 3.00 p.m. and between 6.00 p.m. and 10.00 p.m.;
  - (b) on all other days, between 11.00 a.m. and 3.00 p.m. and between 5.00 p.m. and 10.00 p.m."
- (b) in paragraph (5) by replacing sub-paragraphs (a) and (b) with the following—
  - "(a) to 11.00 p.m. on payment of a fee of E100; or
  - (b) to 12.00 midnight on payment of a fee of E200."

*Amendment of Regulation 8.*

6. Regulation 8 of the principal Regulations is amended in paragraph (1) (a) by replacing "10 a.m. and 2 a.m." with "11.00 a.m. and 12.00 midnight".

*Amendment of Regulation 11.*

7. Regulation 11 of the principal Regulations is amended —

- (a) in paragraph (1) by inserting after the word "consumption" the words "with ordinary meals";
- (b) in paragraph (3) (b) by replacing "11.30 p.m." with "10.00 p.m."; and
- (c) in the proviso thereto by replacing paragraphs (a) and (b) with the following —
  - "(a) 11.00 p.m. on payment of a fee of E100;
  - (b) 12.00 midnight on payment of a fee of E200".

*Amendment of Regulation 12.*

8. Regulation 12 of the principal Regulations is amended —

- (a) by replacing paragraph (3) with the following —
  - "(3) A licence granted under this section shall entitle the holder thereof to sell liquor except on Sundays and public holidays as follows —
    - (a) on Saturday between 9.00 a.m. and 1.00 p.m.;
    - (b) on all other days between 9.00 a.m. and 5.00 p.m."

*Amendment of Schedule.*

9. The Schedule to the principal Regulations is replaced with the following new schedule—
