(Act No. 28 of 1968)

THE PRICES OF BUTTER AND CHEESE REGULATIONS, 1981

(Under section 24)

In exercise of the powers conferred by section 24 of the Dairy Act, 1968 and on the recommendation of the Swaziland Dairy Board, the Minister for Agriculture and Co-operatives hereby makes the following Regulations —

Citation and commencement.

1. The regulations may be cited as the Prices of Butter and Cheese Regulations, 1981 and shall come into force on the 20th day of November, 1981.

Maximum selling prices of butter.

2. (1) The maximum selling price of Grade 1 butter by a producer, processor, manufacturer or importer of butter to a restaurant, hotel, milk shop, dairy or milk purveyor shall be E3,10 per kilogramme.

(2) The maximum selling price of Grade 1 butter to a consumer shall be E3,28 per kilogramme.

Maximum selling prices of cheese.

3. (1) The maximum selling price of Grade 1 cheese by a producer, processor, manufacturer or importer of cheese to a restaurant, hotel, milk shop, dairy or milk purveyor shall be in the case of cheddar cheese E3,48 per kilogramme and in the case of gouda cheese E3,58 per kilogramme.

(2) The maximum selling price of Grade 1 cheese to a consumer shall be E3,75 per kilogramme in the case of cheddar cheese and E3,85 per kilogramme in the case of gouda cheese.

4. The Prices of Butter and Cheese Regulations, 1981 are hereby revoked.
