NOTICE, 1981**

(Under Section 131 of the repealed Constitution)

In exercise of the powers contained in Section 131 of the repealed Constitution, I hereby issue the following Notice:-

Title.

1. This Notice may be cited as the Prescription of Statutory Salaries and Allowances Notice, 1981.

Prescription of salaries and allowances.

2. Without Prejudice to any other benefits, the holder of an office specified in the first column of the Schedule shall, with effect from the date set out in respect of such office, be paid not less than the salary or allowance, or both (as the case may be), specified in relation to the holder, in the second, third and fourth columns of that Schedule.
