THE SWAZILAND RAILWAY ACT, 1962

(Act No. 15 of 1962)

NOTICE OF INTENTION TO EXTEND RAILWAY LINE

(Under Section 30)

It is hereby notified that it is intended to extend the existing railway line from Mpaka to a point approximately four kilometres south — east of Bordergate Border Post in the manner set out herein and with such minor deviations as may be necessary or desirable:

Starting at Mpaka Station and running along the west side of the existing railway in a north-easterly direction across Farm 1049 (SA 27); thence to a point approximately 700 metres north of the common boundary between Farm 1049 and the remaining extent of Farm 704 where it turns in a general north-westerly direction across the remaining extent of Farm 704; thence in a north westerly direction across the remaining extent of Portion B of Farm 704 to cross the White Mbuluzi River approximately 3 kilometres downstream of its junction with the eastern boundary of the remaining extent of Farm 78; thence in a northerly direction across Farm 1044 (SA 22) to cross the Black Mbuluzi River approximately 2 kilometres downstream of its junction with the eastern boundary of the remaining extent of Farm 78; thence in a northerly direction across the remaining extent of Farm 860; thence in a northerly direction across the remaining extent of Farm 94; thence in a north-westerly direction across Portion 4 of Farm 94; thence in a northerly direction across the remaining extent of Farm 94 to cross the Swaziland—Transvaal border at a point approximately 4 kilometres south-east of Bordergate Border Post.

A plan showing in detail the route to be traversed by the said line of railway shall lie for inspection at the offices of the Ministry of Works, Power and Communications, Mbabane for twenty-one days from the date of publication hereof during which period any person wishing to make representation in regard thereto is called upon to lodge such representation in writing with the Minister for Works, Power and Communications, Mbabane.
