#### (To be presented by the Minister for Finance)

#### MEMORANDUM OF OBJECTS AND REASONS

The object of this Bill is to charge the Consolidated Fund with the sum of three hundred and forty-six million, two hundred and thirty-nine thousand Emalangeni (E346,239,000) for the period commencing on the 1st April, 1988 ending on the 31st March, 1989.

The sum is to be appropriated in the manner set out in the Schedule to this Bill.

#### A BILL

#### entitled

An Act to provide for the appropriation of a certain sum of money for the financial year commencing on the 1st April, 1988 and ending 31st March, 1989.

#### Short title and commencement.

Se . . .

1. This Act may be cited as The Appropriation Bill, 1988 and shall come into force on the 1st April, 1988.

#### Charge to Consolidated Fund.

2. The Consolidated Fund is charged with such sum of money not exceeding in the aggregate three hundred and forty-six million, two hundred and thirty-nine thousand Emalangeni (E346,239,000) as required for the services of the Government of the Kingdom of Swaziland during the financial year commencing on the 1st April, 1988 and ending on the 31st March, 1989.
