"The Motif Depicts an oblong Shaped Swazi Shield. On the Right Lower Inside of the Shield is a modern Push Button Telephone Instrument whereas a double faced envelope on which one is affixed a Letter Postage Stamp is on the left lower side. On the upper part of the Shield, the name of the Corporation is written as Posts and Telecommunications Corporation with the word Swaziland Appearing on the Top outside of the Shield. At the Bottom outside is placed the word Phutfumani which is the Corporation Slogan meaning "Let Us Communicate Hurriedly." Superimposed at the back of the Shield are a Battle Axe and a Knobkerrie which are Swazi Nation Traditional Way of Life. On both sides of the Shield is the Laurel which is a Universal Sign of Victory."

"As far as the colours of the Emblem are concerned, the Shield shall be black and white Depicting Multiracial relationship ably encouraged in the Kingdom. The Telephone shall be red with the envelope white. The writings of words shall be in gold letters throughout and so shall be the Laurels. The battle Axe, the Knobkerrie and the Scroll shall be in silver."
