# THE NATIONAL AGRICULTURAL MARKETING BOARD ACT, 1985 (Act No. 13 of 1985)

#### THE SCHEDULED PRODUCTS (AMENDMENT) REGULATIONS, 1991

(Under Section 15)

In exercise of the powers conferred by section 15 of the National Agricultural Marketing Board Act, 1985, the Minister for Agriculture and Co-operatives hereby makes the following Regulations—

#### Citation and commencement.

1. These Regulations may be cited as the Scheduled Products (Amendment) Regulations, 1991 and shall be deemed to have come into force on the 1st April, 1991.

Amendment of Legal Notice No. 40 of 1986.

- 2. The Scheduled Products Regulations, 1986 are amended by the addition of paragraph (e) after paragraph (d) to read—
  - "(e) All slaughtered poultry and poultry products including:
    - Frozen chicken
    - Frozen chicken pieces
    - Chilled chicken
    - Chilled chicken pieces
    - Table eggs."
