STATUTORY CONTRIBUTIONS REGULATIONS, 1991

(Under Sections 14, 15 and 17)

In exercise of the powers conferred by Sections 14, 15 and 17 of the Swaziland National Provident Fund Order, 1974 and after consultation with the Minister for Finance, the Hon. Minister for Labour and Public Service hereby makes the following Regulations—

*Citation and commencement.*

1. These Regulations may be cited as the Swaziland National Provident Fund (Statutory Contributions) Regulations, 1991, and shall come into force on 1st January, 1992.

*Level of wages.*

2. A contributing employer shall pay statutory contributions in respect of eligible employees wages of E250 or less during any calendar month.

*Statutory contributions.*

3. A contributing employer shall, after every contribution period, pay into the Fund a statutory contribution in respect of each eligible employee employed by him during every such period at the rate prescribed in the Schedule hereto.

*Employer's share.*

4. A contributing employer who is required to pay a statutory contribution in respect of an employee may deduct the "employee's share" of such contribution from the wages due from him to that employee at the rate prescribed in the Schedule hereto.

*Revocation of Legal Notice No. 135 of 1988.*

5. The Statutory Contributions Regulations, 1988 are hereby revoked.

THE NATIONAL AGRICULTURAL MARKETING BOARD ACT, 1985

THE IMPORT AND EXPORT OF SCHEDULED PRODUCTS REGULATIONS, 1991

(Under Section 15)

In exercise of the powers conferred by Section 15 of the National Agricultural Marketing Board Act, 1985 the Minister for Agriculture and Co-operatives hereby makes the following Regulations:

*Citation.*

1. These Regulations may be cited as the Import and Export of Scheduled Products Regulations, 1991.

*Interpretation.*

2. In these Regulations "Act" means the National Agricultural Marketing Board Act, 1985.

*Registration of Importers and Exporters of Scheduled Products.*

3. (1) No person shall engage in the importation or exportation of scheduled products unless he has applied to be registered by the Board.

(3) An application to the Board for registration under sub-paragraph (1) shall be in the form prescribed in the Schedule to these Regulations.

(3) Every application for registration shall be accompanied by a fee of E10 which is refundable if the application is unsuccessful.

*Permits.*

4. (1) The Board shall, upon registration of any person under paragraph 3, issue to that person a permit which shall entitle him to import or export scheduled products.

(2) No permit shall be required for the importation or exportation of scheduled products which do not exceed 20 kilogrammes in weight.

*Duration of Permit.*

5. A permit issued or renewed under paragraph 4 or paragraph 6 shall be valid for a period of one month, and shall expire on the last day of the month for which it was issued or renewed.

*Renewal of Permits.*

6. A permit issued under paragraph 4 may be renewed upon application made to the Board by the holder of the permit for a period of one month.

*Levy on Scheduled Products.*

7. The Board may by notice published in the Gazette impose under Section 6 of the Act such levy as may be appropriate on the value of scheduled products.

*Revocation.*

8. The following Legal Notices are hereby revoked.

The Import and Export of Scheduled Products Notice, 1986; and

The Import and Export of Scheduled Products (Amendment) Notice, 1988.

*Unexpired Permits to be valid*

9. Permits issued by the Board before the commencement of these Regulations which haven't expired shall be valid until they expire.
