THE SUGAR EXPORT LEVY NOTICE, 1994

(Under Section 3)

In exercise of the powers conferred on him by section 3 of the Sugar Export levy Order No. 7 of 1973, the Minister for Finance hereby issues the following Notice:

Citation and Commencement.

1. This Notice may be cited as the Sugar Export Levy Notice, 1994 and shall be deemed to have come into force on 1st May, 1993.

Increase of Figure in Section 3.

2. The figure "1085" in section 3 of the Sugar Export Levy Order, 1973 is hereby replaced with the figure "1250".
