DECLARATION OF MANZINI TOWNSHIP (EXTENSION NO. 11) REGULATIONS, 1994

(Under Section 12)

In exercise of the powers conferred by Section 12 of the Crown Lands Disposal Act, 1911, the Minister for Housing and Urban Development hereby makes the following Regulations:-

Citation and Commencement.

1. These Regulations may be cited as the Manzini Township (Extension No. 11) Regulations 1994, and shall be deemed to have come into force on the 2nd October, 1991.

Establishment of Township and alteration of General Plan.

2. (a) The following land is hereby proclaimed and established as a Township:-

CERTAIN: Farm No. 1278 situate in the District of Manzini Swaziland.

MEASURING: 3,6229 (three comma six two two nine) hectares.

HELD: Under certificate of Registered Title No. 453 of 1992 dated 22nd October, 1992 comprising of

11 (eleven) Lots Numbered 1219 to 1229 and roads as will more fully appear from the General

Plan SG S. No. 38/87, accordingly.

Endorsement of Title Deeds and opening of register.

- 3. The Register of Deeds shall:-
 - (a) Make necessary endorsement on the relevant Title Deeds and;
 - (b) Open the necessary Register in connection with the Township.
