**THE STOCK DISEASE REGULATIONS, 1994**

(Under Regulations 11)

In exercise of the powers conferred on him by regulation 11 of the Animal Disease Act, 1965 the Director of Veterinary Services issues the following notice.

*Citation and commencement.*

1. This Notice may be cited as the Dipping of Stock Notice, 1994 and shall come into force on the 1st day of June, 1994.

*Compulsory Dipping of Stock.*

2. (i) Subject to sub-rule (2) all owners of cattle in Swaziland shall dip their cattle once every fourteen (14) days.

(ii) Notwithstanding sub-rule (1) owners of cattle in the schedule hereto shall dip their cattle once every twenty-eight (28) days.

*Dipping Hours.*

3. Subject to any order to the contrary issued by an officer authorized under regulation 11, dipping hours under regulation (2) of this notice shall be between 5.00 a.m. to 12 noon.

*Revocation of Legal Notice No. 94 of 1993.*

4. The Dipping of Stock Legal Notice No. 94 of 1994 is hereby revoked.

LEGAL NOTICE NO. 103 OF 1994

THE STOCK DISEASE REGULATIONS, 1933  
THE INOCULATION OF DOGS AGAINST RABIES  
(Under Regulation 16)

In exercise of the powers conferred by regulation 16 of the Stock Disease Regulation, 1933 the Director of Veterinary Services hereby issues the following notice:-

*Citation and Commencement.*

1. This notice may be cited as the Inoculation of dogs against Rabies Notice 1994 and shall come into operation on 1st June, 1994.

*Compulsory Vaccination against Rabies:*

2. A person who owns a dog or dogs and lives in an area specified in schedule to this notice shall present the dog or dogs at the Inoculation Centre and at the time specified in the schedule for vaccination against Rabies with an approved vaccine.

*Offence and Penalty:*

3. Any owner of a dog or dogs who lives in an area specified in schedule to this Notice who fails to produce the dog or dogs in his possession or under his control at the inoculation centre for inoculation during the hours specified shall be guilty of an offence and upon conviction liable to a fine of fifty Emalangenis or in default of payment thereof to imprisonment for a period not exceeding three months.
