(Act No. 6 of 1965)

THE ROAD TRAFFIC (REGISTRATION LETTER AMENDMENT) REGULATIONS, 1994

(Under Sections 137 and 148)

In exercise of the powers conferred by sections 137 and 148 of the Road Traffic Act, 1965 (Act No. 6 of 1965) the Minister of Transport and Communications hereby makes the following regulations:

Citation.

1. These Regulations may be cited as the Road Traffic (Registration Letter Amendment) Regulations, 1994 and shall be read as one with the Road Traffic Regulations, 1966, hereinafter referred to as "the principal Regulations."

Amendment of the First Schedule.

2. The First Schedule of the principal Regulations is hereby amended by the substitution for Part II of the following Part -

PART II

Allocation of registration numbers.

Motor vehicles, other than Government vehicles or those lawfully used under the authority of a motor vehicle dealer's licence or of diplomatic or consular representation, shall be allotted registration numbers as follows:

- (a) a registration number, consisting of three numerals, followed by a capital letter of the alphabet and a second capital letter denoting the district in which the owner resided on first registration of the motor vehicle concerned;
- (b) the three numerals shall commence with the number 001 and progress to 999;
- (c) the first capital letter shall commence with the letter "A" and progress to "Z", but the letter "Q" shall be omitted;
- (d) the second capital letter, denoting the district of residence of the owner, shall be as follows:
 - (i) "H", for the district of Hhohho, which will be substituted by the letter "G" when all the unique numbers using the letter "H" have been used, which will be further substituted by the letter "F" when all the unique numbers using the letter "G" have been used;
 - (ii) "M", for the district of Manzini, which will be substituted by the letter "N" when all the unique numbers using the letter "M" have been used, which will be further substituted by the letter "O" when all the unique numbers using the letter "N" have been used;
 - (iii) "L", for the district of Lubombo, which will be substituted by the letter "K" when all the unique numbers using the letter "L" have been used, which will be further substituted by the letter "J" when all the unique numbers using the letter "K" have been used;

- (iv) "S", for the district of Shiselweni, which will be substituted by the letter "T" when all the unique numbers using the letter "S" have been used."

ANIMAL DISEASE ACT, 1965

(Act No. 7 of 1965)

THE STOCK DISEASE (RABIES NO. 1) REGULATIONS, 1994

(Under Section 3)

In exercise of the powers conferred by Section 3 of the Animal Diseases Act, 1965 the Minister for Agriculture and Cooperatives hereby makes the following Regulations.

Citation and Commencement.

1. These Regulations may be cited as the Stock Disease (Rabies No. 1) Regulations, 1994 and shall be deemed to have come into force on 30th May, 1994.

Declaration of Rabies Guard Areas.

2. The areas specified in the First Schedule hereto are hereby declared to be Rabies Guard Areas.

Isolation and Confinement of Dogs.

3. Every owner of a dog or cat in a guard area shall isolate and confine his dog or cat so as to prevent it from escaping from such guard areas.

Presentation of Dogs and Cats for Inoculation.

4. A person who owns a dog or cat and lives in an area specified in the second Schedule to this Notice shall present the dog or cat for inoculation at the Inoculation Centre and at the time specified in this Schedule.

Offence and Penalty.

5. An owner of a dog or cat who fails to comply with Regulation 3 shall be guilty of an offence and upon conviction, liable to a fine not exceeding E300.00 or in a default payment, to imprisonment for a period not exceeding 3 months.

Destruction of Dogs and Cats in Rabies Guard Areas.

6. Government Veterinary Officers may destroy a dog or cat in any of the Rabies guard areas if in his opinion, the dog or cat has not been confined so as to prevent it from escaping from such guard areas.
