THE SEDITION AND SUBVERSIVE ACTIVITIES (AMENDMENT) BILL, 1994

(Bill No. 7 of 1994)

(To be presented by the Minister for Justice)

MEMORANDUM OF OBJECTS AND REASONS

The object of this Bill is to create a new offence and a penalty thereto.

A BILL
entitled

An Act to amend the Sedition and Subversive Activities Act, 1938.

ENACTED by the King and Parliament of Swaziland.

Short title.

1. This Act may be cited as the Sedition and Subversive Activities (Amendment) Act, 1994 and shall be read as one with the Sedition and Subversive Activities Act, 1938 (hereinafter referred to as "the principal Act").

Amendment of section 3.

2. Section 3 of the principal Act is amended in subsection (1) (a) after the words "or successors" by adding the words "or Indlovukazi."

Amendment of section 4.

3. Section 4 of the principal Act is amended -

(a) by renumbering section 4 as section 4 (1)

(b) by deleting the offence and penalty after paragraph (e) and by adding the following paragraph:-

"(F) makes or publishes false or derogatory statement about His Majesty the King or Indlovukazi."

(c) by adding the following subsections -

"(2) (a) a person who contravenes subsection (1) (a)

(b), (c), (d) and (e) shall be guilty of an offence and liable on conviction to imprisonment not exceeding 20 years or to a time not exceeding E20,000.00.

4. A person who contravenes subsection (1) (f) shall be guilty of an offence and liable on conviction to imprisonment not less than 10 years but not exceeding 20 years or to a fine not less than E20,000.00 but not exceeding E400,000.00 and if the person is a body corporate the Managing Director, Manager, Editor and publisher shall all be liable to such penalty.

5. Any seditious publication relating to an offence under this section shall be forfeited to the Government.
