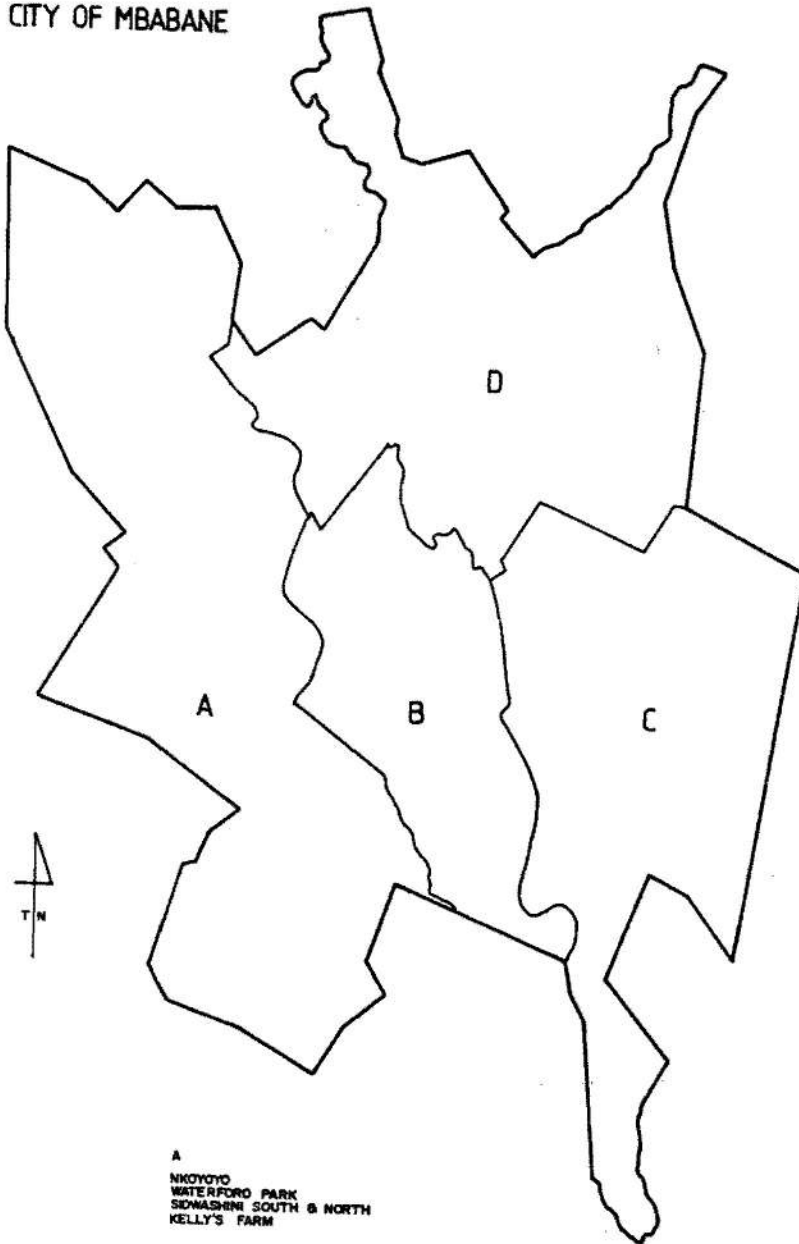

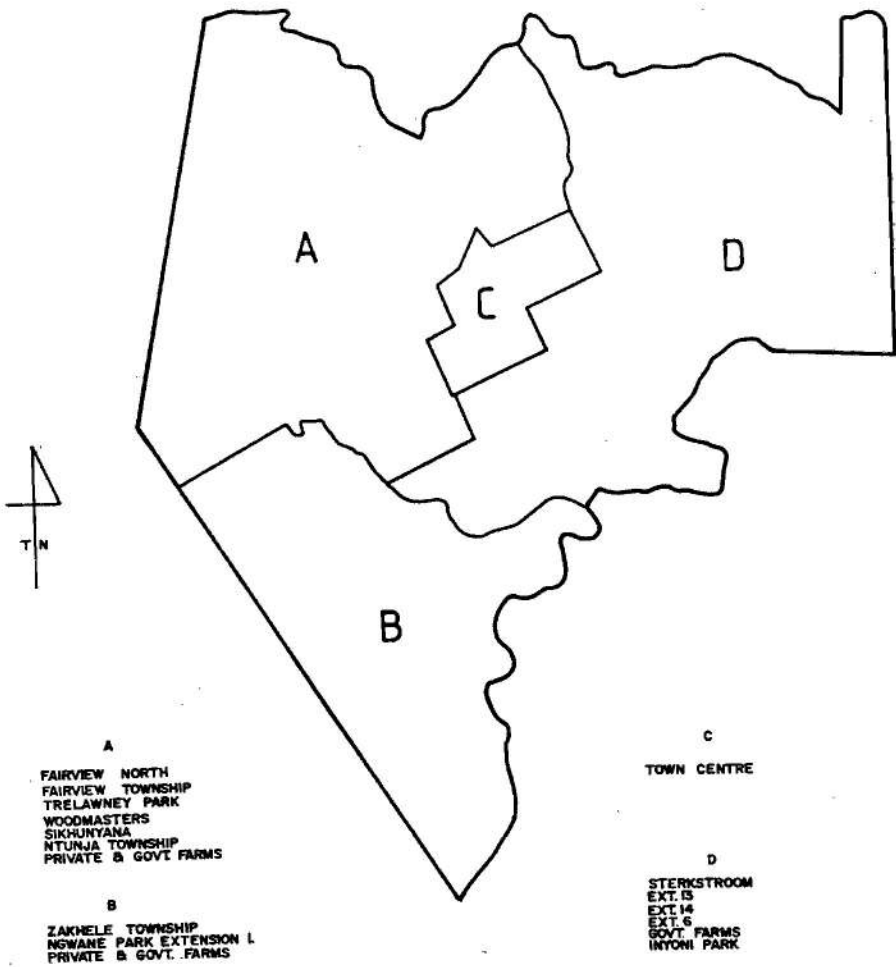

h) in Regulation 3 (8), by replacing the words "rateable property" with the words "immovable property".

Amendment of Regulation 7.

3. Regulation 7 of the principal Regulations is amended in Regulation 7 (2) (b) by deleting the words "the nature and "and "and whether owner or occupier".
