THE COMMISSIONS OF ENQUIRY ACT, 1963

(Act No. 35 of 1963)

THE ESTABLISHMENT OF A COMMISSION TO REVIEW REPRESENTATIONS ON
THE INTENTION TO DECLARE EZULWINI AN URBAN AREA

(Under Section 3)

In exercise of the powers conferred by Section 3 of the Commissions of Enquiry Act, 1963, I hereby issue the following Notice.

1. Citation and Commencement.

This Notice may be cited as the Review of Representations on Ezulwini Urban Area Commission Notice, 1995 and shall come into force on the date of publication of this Notice.

2. Establishment and Composition of Commission.

1) There is established a commission to be called the Review Commission into Representations on the Ezulwini Urban Area (herein after called "the Commission").

2) The Commission shall consist of the following:

Mr. Patrick Zwane	-	Chairman
Mr. Brian Fitzpatrick	-	Member
Director of Urban Government, Ministry of Housing and Urban Development	-	Secretary

3. Functions of the Commission.

a) The Commission shall consider representations received in response to the notification published under Section 111 of the Urban Government Act, 1968 and to advise the Minister for Housing and Urban Development whether or not the intended notice to declare the Ezulwini Urban Area, referred to in such notification, should be published.

b) In the performance of its functions, and in exercise of its powers, the Commission may invite the persons who have made representations in response to the subject notice to appear personally before the commission to submit their opinions.

4. Quorum.

The quorum of the Commission shall be two members.

5. Venue and Address of the Commission.

a) The Enquiry shall be held at the Ministry of Housing and Urban Development Board Room, Mbabane, or at such other places and at such times as the Chairman may determine.

b) The Address of the Commission shall be P.O. Box 1832, Mbabane.
