(Under Section 3)

In exercise of the powers conferred by Section 3 of the Animal Diseases Act, 1965 the Minister for Agriculture and Cooperatives hereby makes the following Regulations:

Citation and Commencement.

1. These Regulations may be cited as the Stock Disease (Rabies No. 1) Regulations, 1995 and shall be deemed to have come into force on 27th January 1995.

Declaration of Rabies Guard Areas.

2. The areas specified in the First Schedule (Schedule 1) hereto are hereby declared to be Rabies Guard Areas.

Isolation and Confinement of Dogs.

3. Every owner of a dog or cat in a guard area shall isolate and confine his dog or cat so as to prevent it from escaping from such guard areas.

Presentation of Dogs and Cats for Inoculation.

4. A person who owns a dog or cat and lives within the area specified in the first Schedule to this Notice shall present the dog or cat for inoculation at the Inoculation Centre and at the time specified in Schedule 2.

Offence and Penalty.

5. An owner of a dog or cat who fails to comply with Regulation 3 shall be guilty of an offence and upon conviction, liable to a fine not exceeding E300.00 or in a default payment, to imprisonment for a period not exceeding 3 months.

Destruction of Dogs and Cats in Rabies Guard Areas.

6. Government Veterinary Officers may destroy a dog or cat in any of the Rabies guard areas if in his opinion, the dog or cat has not been confined so as to prevent it from escaping from such guard areas.

(Act No. 28 of 1959)

CONTROL OF PRICES OF MAIZE AND MAIZE MEAL NOTICE, 1995

(Under Section 4)

In exercise of the powers conferred by Section 4 of the Control of Cereals Act, 1959, the Minister for Agriculture and Cooperatives hereby issues the following notice:-

1. This notice may be cited as the Control of prices of Maize and Maize Meal Notice, 1995 and shall be deemed to have come into force on the 1st January, 1995.

Interpretation.

2. In this Notice:-

"bag of maize" means a unit of 70kg weight of maize fit for human consumption and packed in a sound container;

"burlap or jute bag" means a sack made of natural jute fibres;

"plastics bag" or "polypropylene bag" means a sack made of synthetic fibres;

"sound container" means a bag of not less than Grade I second hand quality.

Minimum price of white maize produced in Swaziland.

3. Subject to section 6, a buyer who purchases maize produced in Swaziland shall pay to the producer or seller not less than E42.50 per 70kg of white maize.

Price of bag and weight computation.

4. (1) Subject to section 6 producers delivering maize in bags will receive 25 cents for each bag as compensation for wear and tear of the bag irrespective of the quality of the bag.

(2) Producers selling the bag along with the maize will be paid E2.00 for a Grade I bag and a negotiated price for used bags other than Grade I quality bags.

(3) The net weight of a bag under this section shall be computed by subtracting the weight of the empty bag, which weight has been fixed as follows:-

(a) the weight of a burlap bag or jute bag shall be 1kg; and

(b) the weight of a synthetic fibre bag shall be 0.15kg.

Content of Moisture.

5. (1) Maize of a moisture content of up to but not exceeding 13 per cent shall be accepted by all buyers.

(2) Notwithstanding subsection (1) maize with a moisture content not exceeding 18 per cent shall be accepted at government silos at Matsapha provided a pro rata deduction shall

be made for maize with a moisture content exceeding 13 per cent. The pro rata deduction will comprise a mass loss component and a drying charge as set out in schedule 1.

Application of Sections 3 and 4.

Section 3 and 4 shall apply:-

6. (1) only in the case of white maize in a sound container;
 (2) for maize of a moisture content up to but not exceeding 13 per cent; and

Cartage Allowance.

7. (1) Where the producer or seller delivers maize to the buyer at an authorized place other than Matsapha, there will be no cartage allowance as this is covered in the price specified in sub-section 3.

(2) Where the producer or the seller delivers a minimum of 10 tonnes of maize in bulk to the buyer at Matsapha, the price specified in section 3 shall be increased by the transport charges incurred by him according to the rates specified in schedule 2.

8. The control of prices of Maize and Maize Meal Notice No. 94 of 1994 is hereby revoked with effect from 1st January 1995.

LEGAL NOTICE NO. 22 OF 1995

THE WAGES ACT NO. 16 OF 1964

THE REGULATION OF WAGES (DOMESTIC EMPLOYEES) ORDER, 1995

(Under Section 11)

In exercise of the powers conferred upon him by Section 11 of the Wages Act, 1964, the Minister for Labour and Public Service hereby makes the following Order:-

Citation.

1. This Order may be cited as the Regulation of Wages (Domestic Employees) Order, 1995 and shall be deemed to have come into effect on the 1st November, 1994.

Interpretation.

2. In this Order, unless the context otherwise requires:-

"Casual employee" means a domestic employee who is employed for not more than one day at a time and who is paid at the end of the day's work;

"Children's nurse" means a person who takes care of children and oversees their activities, gives children all necessary assistance, carries out such other duties in connection with the care of children, including the washing of their clothes, as may be required.

"Cook" means a person who is capable of, and is mainly engaged in, preparing and cooking meals suitable to the dietary and other requirements of the household in which he is employed and who may be required to assist in other household duties;

"Domestic employee" means any person employed in or about any private household or part thereof in capacity of cook, house attendant, waiter, butler, children's nurse, valet, groom, gardener, laundress, or watchman;

"Gardener" means a person who carries out all gardening activities including the planting and cultivation of flowers, shrubs and vegetables, maintains lawns and paths and attends to cleanliness of compounds and yards and, who may be required to carry out other duties such as cleaning vehicles;

"House attendant" means a person who carries out domestic duties including the preparation of food, washing of dishes, cleaning rooms, dusting and polishing furniture, washing windows, washing clothes and textiles by hand and ironing them, making bed etc;

"Laundress" means a person who is mainly employed to carry out washing of clothing using either the washing machine or washing the clothing by hand and ironing them using any kind of iron;

"Part time employee" means a domestic employee, other than a casual employee, who is employed for less than twenty four hours in any week;

"Public holidays" means a public holiday mentioned in the Regulation 9 (1)

"Watchman" means a person who is responsible for the safeguard of his employer's property against fire, theft and illegal entry; carries out such other duties as are similar to these responsibilities, as required by his employer;

Application.

3. This Order shall apply to all persons employed as domestic employees as specified in the First Schedule.

Basic minimum wage.

4. (1) The basic minimum wage to be paid to employees specified in the First Schedule shall be calculated at a rate not less than that specified therein.

(2) The daily and hourly rates specified in the First Schedule shall be the basic minimum wage applicable to part time and casual employees only.

Hours of work.

5. The normal working week shall consist of forty-eight hours, exclusive of meal breaks, spread over six days of the week each of either eight hours or as may be agreed between the employer and the employee.

Overtime.

6. An employee required to work in excess of the normal hours of work referred to in Regulation 5 on any day as agreed between the employee, shall be paid for such overtime at the rate of one and half times his normal rate of wages. For any time worked on Public holidays specified in Regulation 9 and during off days shall be paid at double time.

Annual leave.

7. (1) On completion of each of twelve months continuous service with an employer, an employee shall, at a time convenient to his employer, be entitled to annual leave of not less than twelve working days with full pay.

(2) Any employee whose services are terminated after three months' service other than for reasons of misconduct, shall be paid at the time of termination pro rata cash payment in respect of wage earned but not taken. Such pro rata cash payment shall be equal to three quarters of a day's wages for each month during which leave had been earned but not taken.

Sick Leave.

8. (1) After three months of consecutive service with an employer and subject to the production of medical certificate signed by medical Practitioner, registered under the Medical and Dental Practitioners Act, 1970, an employee shall be entitled to sick Leave up to a maximum of fourteen days on full wages and thereafter to a maximum of fourteen days on half wages in each period of twelve months continuous service.

(2) Notwithstanding Sub-Regulation (1)

(3) An employee shall not be entitled to the benefits if the sickness or accident causing his absence was caused by his own negligence or his misconduct;

(4) A certificate issued by a registered nurse shall be accepted in place of medical certificate if a Medical Practitioner is not available.

Paid Public Holidays.

9. (1) The following shall be public holidays with full pay

- Ascension Day
- Easter Monday
- Good Friday
- Incwala Day
- King's Birthday
- Umhlanga (Reed Dance) Day
- Somhlolo Independence Day
- Christmas Day
- New Years' Day
- National Flag Day

(2) No employee shall be entitled to payment under Sub Regulation (1) unless he is available for work on a working day immediately before and after the public holiday.

Maternity Leave.

10. (1) After nine months of continuous service with an employer, and subject to the production of a certificate signed by a registered nurse recommending that an employee should refrain from work because she is pregnant, an employee shall be entitled to thirteen working days maternity leave on full pay thereafter without pay in respect of that pregnancy.

(2) Such leave shall be in addition to any sick leave to which the employee may be entitled under Regulation 8.

Uniforms.

11. An employer shall, as a condition of employment, provide suitable uniform for the domestic employee, employed as a casual employee, or part time employee. Such uniform shall remain the property of the employer.

Conditions of employment.

12. As a condition of employment, an employee may enter into a written agreement with his employer.

Rest day.

13. Every employee shall be granted one rest day each week; such day to be fixed by mutual agreement between the employee and his employer.

Accommodation.

14. Where an employer requires an employee to occupy accommodation provided by the employer as part of his conditions of employment, such accommodation shall be provided free of charge to the employee.

Revocation of legal Notice No. 115 of 1993.

15. The Regulation of Wages (Domestic Employees) Order, 1993 is hereby revoked.

The hourly rate specified in the third column of the Schedule shall be the basic minimum wage for casual employees employed casually and paid by the hours inclusive of the ration element.

LEGAL NOTICE NO. 23 OF 1995

ANIMAL DISEASE ACT, 1965

(Act No. 7 of 1965)

THE STOCK DISEASE (RABIES NO. 2) REGULATIONS, 1995

(Under Section 3)

In exercise of the powers conferred by Section 3 of the Animal Diseases Act, 1965 the Minister for Agriculture and Cooperatives hereby makes the following Regulations:

Citation and Commencement.

1. These Regulations may be cited as the Stock Disease (Rabies No. 2) Regulations, 1995 and shall be deemed to have come into force on 10th February 1995.

Declaration of Rabies Guard Areas.

2. The areas specified in the First Schedule (Schedule 1) hereto are hereby declared to be Rabies Guard Areas.

Isolation and Confinement of Dogs.

3. Every owner of a dog or cat in a guard area shall isolate and confine his dog or cat so as to prevent it from escaping from such guard areas. Such confinement and isolation shall remain in force until further notice.

Offence and Penalty.

4. An owner of a dog or cat who fails to comply with Regulation 3 shall be guilty of an offence and upon conviction, liable to a fine not exceeding E300.00 or in a default payment, to imprisonment for a period not exceeding 3 months.

Destruction of Dogs and Cats in Rabies Guard Areas.

5. Government Veterinary Officers may destroy a dog or cat in any of the Rabies guard areas if in his opinion, the dog or cat has not been confined so as to prevent it from escaping from such guard areas.
