THE SWAZILAND NATIONAL PROVIDENT FUND (AMENDMENT) BILL, 1995

(Bill No. 3 of 1995)

(To be presented by the Minister for Labour and Public Services)

MEMORANDUM OF OBJECTS AND REASONS

The object of this Bill is to amend the Swaziland National Provident Fund Order, 1974 so as to-

- (a) enable a member of the Fund who has been paid an invalidity benefit to be entitled to further payment only after the expiration of a period of not less than two years from the date the last payment was made;
- (b) clarify that the investment committee is responsible to, and acts on behalf of, the Board;
- (c) make a contributing employer who goes into liquidation to be responsible for the payment of the full amount due to the Fund at the time of such employer's liquidation; and
- (d) provide for matters incidental thereto.

An Act to amend the Swaziland National Provident Fund Order, 1974.

ENACTED by the King and Parliament of Swaziland

Short title.

1. This Act may be cited as the Swaziland National Provident Fund (Amendment) Act, 1995, and shall be read as one with the Swaziland National Provident Fund Order, 1974 (hereinafter referred to as "the Order.")

Amendment of section 2.

2. Section 2 of the Order is amended by replacing the definition of "Minister" with the following-

"Minister" means the Minister responsible for Labour and Public Service.

ADDITION of section 15 bis.

3. The Order is amended by adding the following section after section 15 -

"Power to amend Schedules.

15 bis. The Minister may, by notice in the gazette, amend any Schedule made under this Act."

Amendment of section 26.

4. Section 26 of the Order is amended by adding the following subsection after subsection (2) -

"(3) A person who has received a benefit under this section shall not be entitled to a further payment of benefit thereunder until the expiration of a period of not less than two years from the date on which an invalidity benefit was last paid, or, if the benefit is paid in instalments, from the date when the first of such instalments was paid."

Amendment of section 31.

5. Section 31 of the Order is amended as follows -

- (a) in subsection (2) (a) by replacing the words "Minister for Finance and Economic Planning with" Minister for Labour and Public Service."
- (b) in sub-section (2) (c) by replacing it with the new subsection "(2) (c) two persons experienced in financial matters who shall not be public officers appointed by the Minister for Labour and Public Service in consultation with the Minister for Finance"; and
- (c) by adding the following subsections after subsection (6) -
 - " (7) The investment committee shall submit to the Board through the executive officer minutes of its meetings within twenty-one days of each meeting.
 - (8) Decisions of the investment committee on a major investment shall not be implemented unless approved by the Board and the Minister as provided for under section 10 (1) of the Public Enterprises (Control and Monitoring) Act, 1989.
 - (9) A member of the investment committee appointed under subsection (2) (c) shall hold office for a period not exceeding three years and on such other terms and conditions as may be specified in his instrument of appointment."

Amendment of section 32.

6. Section 32 of the Order is amended after the words "investment committee" by replacing the full-stop with a comma and adding the words "provided that the provisions of section 31 (8) have been satisfied."

Replacement of section 38.

7. Section 38 of the Order is replaced with the following new section -

"Priority of payment.

38. Where an employer becomes insolvent or, if the employer is a company, where the company is wound up, any contribution, penalty or other payment due to the fund in respect of any employee by such employer, shall be a preferent claim to the same extent as other preferent claims are treated under the Insolvency Act, 1955."

(Act No. 13 of 1911)

DECLARATION OF MATHENDELE TOWNSHIP EXTENSION NO. 6

REGULATION, 1995

(Under Section 12)

In exercise of the powers conferred by Section 12 the Crown Lands Disposal Act, 1911, the Minister for Housing and Urban Development hereby makes the following Regulations:

Citation and Commencement.

1. These Regulations may be cited as Mathendele Township Extension No.6 Regulations, 1995, and shall be deemed to have come into force on the 2nd March 1995.

Establishment of Township and Alteration of General Plan:

2. The following land is hereby proclaimed and established as a Township:-

CERTAIN: Farm No. 1292 situate in the District of Shiselweni, Swaziland.

MEASURING: 17, 2157 (seventeen comma two one five seven) hectares.

HELD: Under certificate of Registered Title No. 58 of 1995 dated 2nd March 1995 comprising of 253 lots numbered 401 to 651 and public open spaces numbered 652 to 653 and roads as will more fully appear from the General Plan SG No.S.195/93 approved by the Surveyor General on the 28th March 1994.

The Surveyor General shall alter the General Plan so as to indicate the name and lot numbers assigned by these regulations to the township and endorse the General Plan SG No. S.195/93 accordingly.

Endorsement of Title Deeds and opening of register.

3. The Registrar of Deeds shall:-

- (a) Make necessary endorsement on the relevent title deeds; and
- (b) Open the necessary register in connection with the township.
