#### ANIMALS DISEASE ACT, 1965 (Act No. 7 of 1965

#### THE STOCK DISEASE REGULATIONS, 1995 (Under Regulation 11)

In exercise of the powers conferred on him by regulation 11 of the animal Disease Act, 1965 the Director of Veterinary Services issues the following notice.

Citation and Commencement.

1. This Notice may be cited as the Dipping of Stock Notice, 1995 and shall come into force on the 1st day of November, 1995.

Compulsory Dipping of Stock.

- 2. (i) Subject to sub-regulation (2) all owners of cattle in Swaziland shall dip cattle once every seven (7) days.
  - (ii) Not with standing sub-regulation (1) owners of cattle in the schedule here to shall dip their cattle once every fourteen (14) days.

#### Dipping Hours.

3. Subject to any order to the contrary issued by an officer authorised under regulation 11 of the Stock Diseases Regulations 7/1965 (1) dipping hours under regulation (2) of this notice shall be between 5.00 a.m. and 12 noon.

#### Revocation of Legal Notice No. 71 of 1995.

4. The dipping of stock Legal Notice No. 71 of 1995 is revoked.
