## GENERAL NOTICE NO. 7 OF 1999

THE CENTRAL BANK OF SWAZILAND ORDER 1974  
(Kings Order-In-Council No. 6 of 1974)

THE MANUFACTURE AND CHARACTERISTICS OF THE FIFTY  
EMALANGENI NOTE NOTICE 1999  
(Under section 24 (3))

In exercise of the powers conferred by Section 24 (3) of the Central Bank of Swaziland Order, 1974, I hereby issue the following notice:

*Notice and Commencement.*

1. This notice may be cited as The Manufacture and Characteristics Of The Fifty Emalangeni Note Notice 1999, and shall be deemed to have come into force on the 1st April, 1995.

*Legal Tender.*

2. The Fifty Emalangeni Notes issued by the Central Bank of Swaziland under section 24 shall be legal tender as provided under section 23 of the Central Bank of Swaziland Order 1974.

*Size, Weights and background colour of notes.*

3. The notes shall consist of mould-made banknote paper incorporating a watermark and micro-printed security thread, and shall be of the following size, weight and background colour:

SIZE	WEIGHT	MAIN COLOUR
156mm x 72mm	87 gms per square metre	red and brown

*Design and inscription of the notes.*

4. The notes will bear the following designs and inscriptions:

- (1) On the obverse side of the 50 (Fifty) Emalangeni note shall be printed and inscribed -
  - (a) to the left of the centre, the image of His Majesty King Mswati III;
  - (b) to the right of the centre in an unprinted white area, a watermark representing a Swazi shield complete with two spears and a staff;
  - (c) at the top and centrally, the words "CENTRAL BANK OF SWAZILAND" and below those words the words "THIS NOTE IS LEGAL TENDER FOR LANGEMASHUMI LASIHLANU EMALANGENI" - both inscriptions in capital Roman letters.
  - (d) also on the centre of the note, the image of the Parliament Buildings;
  - (e) centrally at the bottom border and partially obscuring the Parliament Buildings, the National Coat of Arms in dark green and the National Coat of Arms shall consist of an image of the Swazi shield with two spears and a staff, an elephant with its trunk raised

on the right of the shield and a lion with its left paw raised on the left of the shield and further the scroll forming the lower border of the Coat of Arms shall bear the inscription "SIYINQABA" in capital Roman Letters;

- (f) on the right hand side of the note, a ceremonial arm band (ingece) overlayed by a shiny lead strip on which is printed "Central Bank of Swaziland";
  - (g) to the left of His Majesty's portrait, the image of a Swazi shield with two spears and a staff with feathers and this image shall be printed in perfect register with a similar feature on the reverse of the note;
  - (h) overlying the image of the Parliament Buildings, the signatures of the Minister for Finance on the left and the Governor of the Central Bank on the right both with facsimile signatures of the incumbents;
  - (i) at the top left, top right and lower right corners, the value 50 (fifty) in arabic numerals;
  - (j) the serial numbers of the note consisting of two Roman capital letters and seven Arabic numerals and -
    - (i) the left-hand serial number, shall be printed horizontally in black ink below the portrait of King Mswati III;
    - (ii) the right-hand serial number, shall be printed vertically in red ink to the left of the watermark area which watermark shall be on the right-hand side of the note;
  - (k) to the left of the centre, a security thread incorporated in the paper of the notice comprising the repeated extra-small text "Central Bank of Swaziland", which shall be visible when the note is viewed against a source of light;
  - (l) to the left of the Swazi shield, and close to the edge of the note, a red round braille mark; and
  - (m) a border of intricate geometric designs.
- (2) On the reverse of the 50 (Fifty) Emalangeni note there shall be printed and inscribed-
- (a) at the top, the words, "Central Bank of" in lower case Roman letters, followed by the word "SWAZILAND" in upper case Roman letters;
  - (b) at the bottom, the words "FIFTY EMALANGENI" in upper case Roman letters;
  - (c) at the top left and top right corners and to the left of centre in lower border, the Arabic numerals "50" (Fifty);
  - (d) to the right of centre, a vignette depicting the building of the Central Bank of Swaziland;
  - (e) to the left of centre, an elliptical motif incorporating the crest of the Central Bank of Swaziland;
  - (f) on the right of the note, an image of a Swazi shield with two spears and a staff, in perfect register with a similar image on the front; and
  - (g) a border of intricate geometric designs similar to those on the front as provided under section 4 (1) (m);

1. The Regulations may be cited as the Administration of the Community Development Special Fund, 1999.

*Interpretation.*

2. In these Regulations, unless the context otherwise requires-

“Fund” means the Community Development Special Fund established under Legal Notice No. 125 of 1998;

“Committee” means the Community Project Steering Committee;

“Regional Committee” means the Regional Development Committee.

*Purposes and objectives of the Fund.*

3. The Fund shall-

- (a) finance approved community projects in terms of these Regulations;
- (b) give grants or assistance to a group of persons who shall not be less than ten in number.

*Funds of the Fund.*

4. Funds of the Fund shall comprise moneys from -

- (a) the Consolidated Fund;
- (b) donors;
- (c) grants from any other sources;
- (d) interest accruing from bank deposits.

*Administration of the Fund.*

5. (1) The Fund shall be in the name of the Government of Swaziland and shall be operated by the Accountant General with an account kept with the Central Bank of Swaziland and all interest shall accrue to the Fund.

(2) All approved expenditure related to community projects shall be charged to the Fund in accordance with Government accounting procedures and proper books of account shall be kept.

(3) The Principal Secretary, Ministry of Economic Planning and Development shall be responsible for the general administration of the Fund.

(4) The Accountant General and the Principal Secretary of the Ministry of Economic Planning and Development shall be co-signatories in respect of any withdrawals of moneys from the Fund.

(5) All claims relating to the Fund shall be cleared within two months of the receipt of invoices or such time as may be agreed upon by the Committee.

(6) Grants lawfully paid from the Fund shall not be payable to the Fund where they have been used for the purpose they were granted.

*Payments from the Fund.*

6. Moneys withdrawn from the Fund shall be used to pay for -

- (a) community projects;
- (b) administrative costs; and
- (c) other costs and expenses as may be approved by the Committee.

*Community Project Steering Committee.*

7. (1) The Minister for Finance shall appoint a Community Project Steering Committee of eight people comprising of Principal Secretaries of the Ministry of Finance, Ministry of Economic

Planning and Development, Ministry of Education, Ministry of Natural Resources and Energy, Deputy Prime Minister's office, Ministry of Agriculture, Ministry of Home Affairs or their representatives, Principal Community Development Officer and the Accountant General and one co-opted member.

(2) This Committee shall consider and approve new project proposals received from the Regional Development Committee.

(3) The Committee shall meet at least once in three months and the chairman shall be the Principal Secretary in the Ministry of Economic Planning and Development.

*Regional Development Committee.*

8. (a) A Regional Committee is established which shall comprise all heads of departments and sections at the regional level, including non-governmental organisations.

(b) The Regional Committee shall appraise and recommend projects to the Committee.

*Contribution by local community.*

9. The local community shall contribute 25% of the investment cost in cash or in kind, such as labour.

*Community project.*

10. (1) The maximum cost for each project shall not exceed E300 000.00 per annum.

(2) The community shall take full responsibility of the maintenance and operating costs of their projects.

(3) To qualify for consideration applications should be endorsed by a Chief, Indvuna Yenkhundla and the Regional Secretary.

*Monitoring of Community projects.*

11. The European Union Microprojects Unit in conjunction with the Principal Secretary, Ministry of Economic Planning and Development shall monitor community projects financed by the Fund in terms of the Regulations for the European Union Microprojects Unit and shall be responsible for the general administration of the Fund.

*Books of accounts.*

12. The Principal Secretary, Ministry of Economic Planning and Development shall ensure that proper books of accounts are kept by the Fund and which books shall be audited annually.

*Annual reports of the Fund.*

13. (1) An annual report on the Fund shall be laid before Parliament six months after the end of Government's financial year.

(2) In the case where an extension is needed, a formal request shall be submitted to the Minister for Finance for approval.
