(Under Section 12)

In exercise of the powers conferred by Section 12 of the Finance Management Act, 1967, the Minister of Finance makes the following Regulations.

Citation and Commencement.

1. These Regulations may be cited as the Administration of the Swaziland Komati Project Enterprise Special Fund Regulations, 1999.

Interpretation.

2. In these Regulations, unless the context otherwise requires -

“Board” means the Board of the Swaziland Komati Project Enterprise Special Fund appointed in terms of Regulation 6;

“Minister” means the Minister responsible for Natural Resources and Energy;

“SKPE” means the Swaziland Komati Project Enterprise Special Fund established under Legal Notice No. 17 of 1999.

Purpose of the Swaziland Komati Project Enterprise Special Fund (SKPE).

3. The purpose of the Swaziland Komati Project Enterprise Special Fund shall be to -
 - (a) finance the co-ordination, monitoring and evaluation programmes arising as a consequence of the construction of Maguga Dam and the subsequent impoundment of water;
 - (b) finance the programme directed towards the utilisation of Swaziland's share of the additional water available on impoundment following the completion of Maguga Dam, through the promotion and facilitation of irrigation and other agricultural programmes, including resettlement and compensation programmes, as approved by the SKPE;
 - (c) receive capital funds, as loans or grants, from the Government of the Kingdom of Swaziland;
 - (d) receive funds, as loans or grants, from commercial institutions;
 - (e) receive assistance and donations from bilateral assistance, public and private persons;
 - (f) receive interest income generated from the operations of the SKPE;
 - (g) receive any other income or funds for its purposes, including rentals, loan recoveries and Government contributions or any other contributions;
 - (h) support the development and provision of business advisory and information services, training facilities, monitoring, and technology transfers to small farmers;

- (i) finance component activities of the downstream development not otherwise financed through commercial institutions; and
- (j) support the expansion of loan financing to small farmers through carefully selected intermediary organisations or agents providing loan finance.

Board of the Swaziland Komati Project Enterprise Special Fund (SKPE).

4. (1) The Minister shall appoint the Members of the Board of the SKPE in consultation with the Standing Committee on Public Enterprise.

(2) The Board shall consist of between five (5) and nine (9) members of whom one shall be Chairman, and at least three (3) shall be deemed from the private sector, on terms and conditions as the Minister deems fit.

(3) The Minister shall, in making the appointments, ensure that an overall balance of technical, professional, commercial and financial skills is maintained in the Board.

(4) The Minister shall, in the interest of continuity, appoint the members in a manner that they do not all at once vacate office.

Term and Vacation of Office of the Board.

5. (1) The Minister shall appoint the members of the Board for a term of office of between two (2) and three (3) years, and may terminate a member's term of office at any time in consultation with the Standing Committee on Public Enterprises.

(2) Subject to sub-Regulation (3), the Minister may renew a member's term of office or reappoint to office a member whose term he terminated, if the Standing Committee on Public Enterprises reasonably believes that person's services are essential to the SKPE.

(3) Notwithstanding any provision of the Regulations, the Minister shall not appoint a person to serve as a member for more than two consecutive terms of office.

The Chief Executive Officer of the Swaziland Komati Project Enterprise Special Fund (SKPE).

6. (1) The Board shall nominate a Chief Executive Officer, on terms and conditions as the Members of the Board deem fit, who may be appointed or dismissed by the Minister acting in consultation with the Standing Committee on Public Enterprises.

(2) The Chief Executive Officer shall be a Board Member.

Supporting Staff of the Swaziland Komati Project Enterprise Special Fund (SKPE).

7. The Board shall, in consultation with the Chief Executive Officer, appoint additional staff for the SKPE as may be necessary and also determine their terms and conditions of service.

Functions of the Board.

8. The Board shall -

- (a) be responsible for the fulfilment of the purpose and administration of the SKPE;
- (b) select or approve the selection of Agents or intermediary organisations for the disbursement, recovery of the loans and any other incidental matters;

- (c) ensure that the operations of the SKPE are subject to reporting in full accordance with Section 7 of the Public Enterprises (Control and Monitoring) Act, 1989;
- (d) ensure that the annual and independent audits are carried out and that the audited accounts and reports of the auditors on the SKPE's operations are submitted to the Minister of Finance for his action;
- (e) hold the water licence for Swaziland's share of the additional waters available on impoundment following completion of Maguga Dam, and to allocate such water to small farmer enterprises within an approved downstream development plan; and
- (f) make its own rules of procedure, including the formation of a quorum and the calling of its meetings.

Mode of Support.

9. (1) The SKPE shall be responsible for entering into such contracts as it shall deem necessary in the fulfilment of its obligations, and making all payments for the same.

(2) The SKPE shall realise its obligations primarily through the promotion of small farmer enterprises.

(3) The Agents or intermediary organisations shall be responsible for the disbursement of the loans and their recovery to the small farmers, together with interest.

Account of the Swaziland Komati Project Enterprise Special Fund (SKPE).

10. (1) The Minister of Finance shall cause to be opened a bank account for and in the name of the SKPE with the Central Bank of Swaziland.

(2) The SKPE shall, in collaboration with the Minister of Finance, pay from the account all operating costs properly incurred in the administration of the SKPE.
