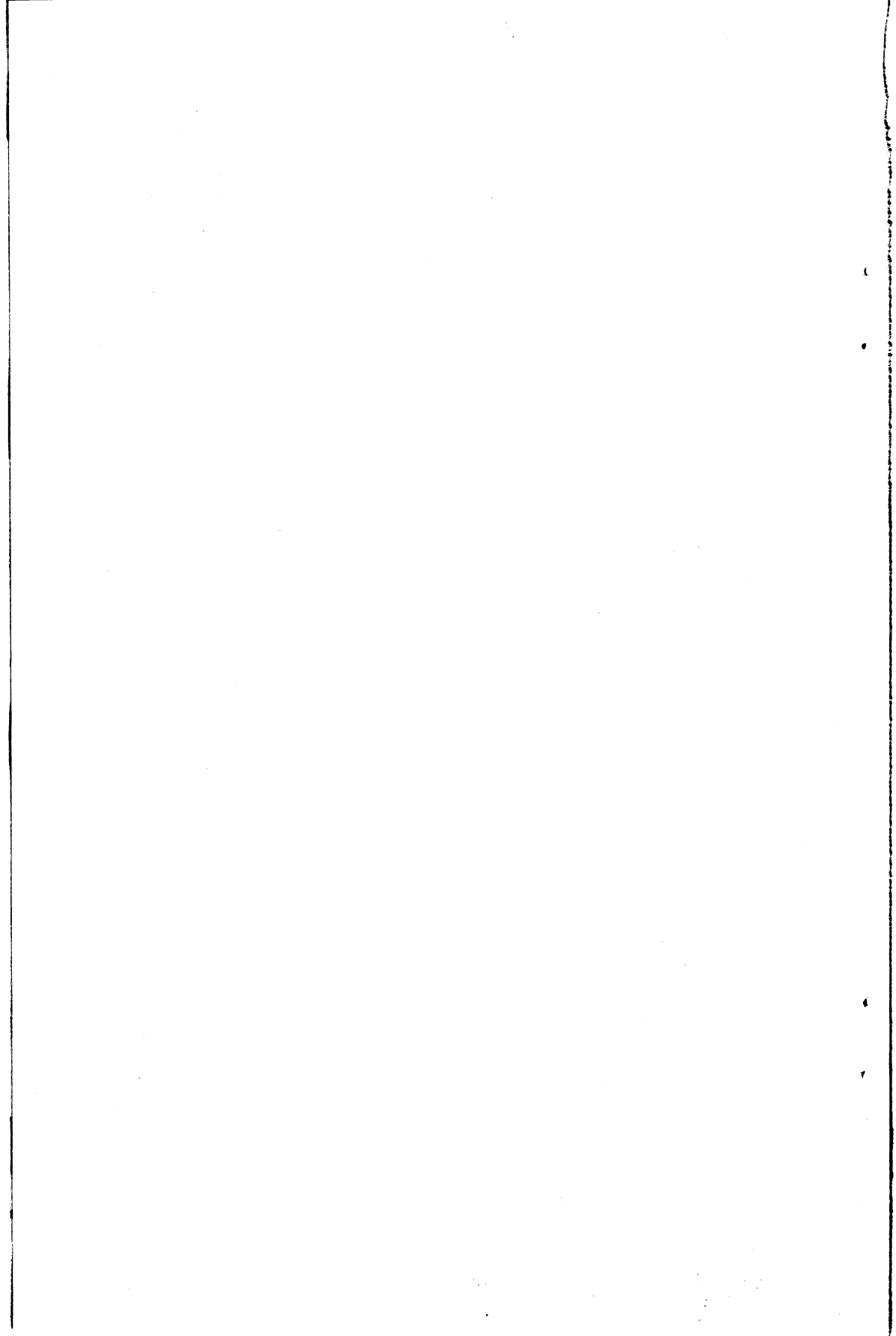

*Citation.*

1. This Notice may be cited as the Notification of Law Officers and Legal Advisors Notice, 2001.

*Offence.*

2. (1) No person, other than a Crown Counsel, shall within the Public Service or in any manner hold himself or herself out as or pretend to be, or make use of any words or any name, title or addition or description implying or tending to the belief that that person is a Crown Counsel, Legal Advisor or Law Officer if that person is not recognized as such by section (2) of the Interpretation Act, 1970, section (2) of the Legal Practitioners Act, 1964 and by the Schedule to this Notice.

(2) Any person who contravenes subsection (1) commits an offence and shall, irrespective of any other disciplinary action which may visit such person, on conviction be liable to a fine not exceeding two hundred Emalangeni.
