LEGAL NOTICE NO. 90 OF 2001

THE URBAN GOVERNMENT ACT, 1969  
(Act No. 8 of 1969)

THE URBAN GOVERNMENT (ELECTIONS) (AMENDMENT) REGULATIONS, 2001  
(Under Section 8)

In exercise of the powers conferred by Section 8 of the Urban Government Act 1969 the Minister for Housing and Urban Development hereby makes the following regulations-

*Citation and Commencement*

1. These Regulations may be cited as the Urban Government (Elections) (Amendment) Regulations, 2001 and shall be read as one with the Urban Government (Elections) Regulations, 1969 (hereinafter referred to as "the Principal Regulations) and shall come into force on publication.

*Amendment of regulation 3*

2. Regulation 3 of the principal Regulations is amended by -

(a) replacing the word 'Swaziland' in sub-regulation 2 (c) with the word "the municipality"

(b) replacing the number "(1)" with the number "(2)" between the words "paragraph" and "in" in sub-regulation 3 (b)

*Amendment of regulation 4*

3. Regulation 4 (2) of the principal Regulations is amended by inserting the words "and be voted for" between the words 'vote' and 'at'

*Amendment of regulation 7*

4. Regulation 7 (2) of the principal Regulations is amended by inserting the words "identity number and a ward number" between the words "full," and 'arranged'.

*Amendment of regulation 12*

5. Regulation 12 of the principal regulations is amended by deleting paragraphs "(c)", "(d)" and "(e)"

*Amendment of regulation 13*

6. Regulation 13 (b) of the principal Regulations is amended by deleting subsection "(b)"

*Amendment of regulation 15*

7. Regulation 15 of the principal regulations is amended by renumbering sub-regulations "(3)" and "(4)" as sub-regulations "(2)" and "(3)" respectively

*Amendment of regulation 16*

8. Regulation 16 (1) of the principal Regulations is amended by inserting the words "or juristic person" between the words 'individual' and "who"

*Amendment of regulation 17*

9. Regulation 17 of the principal Regulations is amended by-

- (a) inserting the words "to contain the provision of section 10 of the Urban Government Act, 1969 between the words "M.E.3" and "which" in sub-regulation (1);
- (b) replacing the number "(5)" with the number "(3)" between the number "15" and the words "between" in sub-regulation (3)

*Amendment of regulation 19*

10. The proviso in regulation 19 of the principal regulations is amended by replacing the number "(5)" with the number "(3)" between the number "(15)" and "(a)"

*Amendment of regulation 24*

11. Regulation 24 of the principal regulations is amended by deleting sub-regulation "(5)"

*Amendment of regulation 28*

12. Regulation 28(4) of the principal regulations is amended by deleting the words "and no councillors"

*Amendment of regulation 66*

13. Regulation 66 (2) of the principal Regulations is amended

- (a) in paragraph (b) by replacing the full stop at the end of the sentence with a semi-colon;
- (b) by adding a new subparagraph (c) as follows-
  - "(c) prepare and complete an elections report for the Minister's consideration".

*Amendment of Part IV*

14. Part IV of the Regulations is amended by adding a new provision as follows-

**"Funding for elections**

69 bis A Local Authority shall finance its elections."
